

ORDINANCES AND RESOLUTIONS PASSED MARCH 19, 2007

ORD. NO. 111-2007 authorizing the Director of Planning and Urban Development to enter into a agreement or agreements with the Urban Neighborhood Development corporation (UNDC) to provide for the construction and sale of moderate cost single-family homes on a non-profit basis within the Community Development Activity Area; authorizing payment therefore; and declaring an emergency.

ORD. NO. 112-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the labor and materials to replace field lighting bulbs at Canal Park; approving specification therefore; and declaring an emergency.

ORD. NO. 113-2007 authorizing a Conditional Use to permit the construction of a deck at 317 Cleveland Street; and declaring an emergency.

ORD. NO. 114-2007 authorizing a Conditional Use to permit the establishment of a veterinary hospital at 1700 West Exchange Street; and declaring an emergency.

ORD. NO. 115-2007 approving and authorizing the execution of a contract for sale for private redevelopment with JBM Holdings, LLC (“Redeveloper”), providing for the sale and redevelopment of property; finding such property is not needed for any public use, and related findings; and declaring an emergency.

RES. NO. 116-2007 declaring the necessity and intent of the City of Akron to appropriate a fee simple interest in real property owned by Paul E. Spencer and Roberta A. Spencer, and located at 319 Cross Street, for the purpose of constructing the Leggett Community Learning Center; and declaring an emergency.

RES. NO. 117-2007 declaring the necessity and intent of the City of Akron to appropriate a fee simple interest in real property owned by Bonita Byrd and William E. Byrd, and located at 345 Cross Street, for the purpose of constructing the Leggett Community Learning Center; and declaring an emergency.

ORD. NO. 118-2007 ratifying the actions of the Director of Public Service in entering into a contract with Kenmore Construction Company and H.M. Miller Construction Co. for emergency snow and ice removal; authorizing payment therefore; and declaring an emergency.

ORD. NO. 119-2007 ratifying the actions of the Purchasing Agent in entering into a contact with American Fleet Services for the emergency repair of Ladder 5, an Akron Fire Department emergency response vehicle; authorizing payment therefore; and declaring an emergency.

ORD. NO. 120-2007 ratifying the actions of the Director of Public Service in contracting with Donley's Inc. for emergency repairs to the apparatus floors at Fire Stations #2 and #12; authorizing payment therefore; and declaring an emergency.

ORD. NO. 121-2007 accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the LEGGETT COMMUNITY LEARNING CENTER project; authorizing payment therefore; and declaring an emergency.
