

ORDINANCES AND RESOLUTIONS PASSED OCTOBER 22, 2007

ORD. NO. 548-2007 amending Ordinance No. 128-2007, passed March 26, 2007, which established the annual appropriation for the current expenses, other expenditures and the capital outlays of the City of Akron for the fiscal year ending December 31, 2007; and declaring an emergency.

ORD. NO. 549-2007 authorizing the Mayor to enter into a loan agreement with Arlington Housing Options Plus Elderly Services to provide funds for the purpose of providing multi-family housing; and declaring an emergency.

ORD. NO. 550-2007 accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the WHITE POND PHASE I project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 551-2007 accepting a utility easement for property described below in the City of Akron, for the WEST MARKET STREET project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 552-2007 accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the MUD RUN WEST project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 553-2007 accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the LAND BANKING project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 554-2007 authorizing the Mayor to enter into a contract, after publicly advertising for bids, for the purchase of city-wide wireless service and equipment; approving specifications therefore; and declaring an emergency.

ORD. NO. 555-2007 authorizing a Conditional Use to construct a bank branch at 1651 Home Avenue; and declaring an emergency.

ORD. NO. 556-2007 accepting the amounts and rates as determined by the Budget Commission of Summit County and authorizing the necessary tax levies and certifying them to the County Fiscal Officer.

ORD. NO. 557-2007 determining to proceed with the improvement of White Pond Drive between the termini of the Wheeling and Lake Erie Railroad track crossing and 500 feet north of Mull Avenue by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches and storm sewers; installing roof drain pipes; installing traffic signalization and street lighting; and planting trees; approving the report of the Assessment Equalization Board; and declaring an emergency.

ORD. NO. 558-2007 authorizing the Director of Public Service to enter into an agreement with the Ohio Director of Transportation for the design and construction of improvements to Massillon Road, George Washington Boulevard, Wilbeth Road and Triplett Boulevard; and declaring an emergency.

ORD. NO. 559-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the repair and reinforcement of the Hawkins Trunk Sewer Lining; approving specifications therefore; and declaring an emergency.

ORD. NO. 560-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of improvements to Fire Station No. 14; approving specifications therefore; and declaring an emergency.

ORD. NO. 561-2007 authorizing the Director of Public Service to purchase four used vehicles at public auction; authorizing payment therefore; authorizing the resale of these vehicles at public auction when they are no longer needed for public use; and declaring an emergency.

ORD. NO. 562-2007 ratifying the actions of the Director of Public Service in contracting with H.M. Miller Construction Company for emergency repairs to the North Summit Supply Main; authorizing payment therefore; and declaring an emergency.

ORD. NO. 563-2007 authorizing the Director of Public Service to enter into an agreement with the City of Cleveland to provide an emergency water connection in order to facilitate the repair of the North Summit Supply Main; and declaring an emergency.

ORD. NO. 564-2007 Ordinance accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the YOUNG'S RESTAURANT project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 565-2007 approving and authorizing the execution of a contract for sale of land for private redevelopment with Don Drumm Studios, Inc. ("Redeveloper"), providing for the sale and redevelopment of property pursuant to the Spicertown Urban Renewal Plan, as amended ("Plan"); finding such property is not needed for any public use, and related findings; and declaring an emergency.
