

ORDINANCES AND RESOLUTIONS PASSED NOVEMBER 26, 2007

ORD. NO. 601-2007 authorizing the Mayor to expend public monies for the Outstanding Employee Recognition Program for 2008; authorizing the Director of Finance to make payment therefore; and declaring an emergency.

ORD. NO. 602-2007 ratifying the actions of the Director of Public Service in entering into a contract with the Vito Girona Construction Company for the emergency removal of the median on Romig Road; authorizing payment therefore; and declaring an emergency.

ORD. NO. 603-2007 ratifying the actions of the Director of Public Service in contracting with Kenmore Construction Co. for emergency repairs to the expressway culvert located under the ramp from eastbound I-76 to the Kenmore leg; authorizing payment therefore; and declaring an emergency.

ORD. NO. 604-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the disposal of miscellaneous "white goods"; approving specifications therefore; and declaring an emergency.

ORD. NO. 605-2007 authorizing the Director of Public Service to enter into a contract with Ohio Machinery Co. for the lease of a wheel loader for the upcoming snow and ice season; authorizing payment therefore; and declaring an emergency.

ORD. NO. 606-2007 authorizing the Director of Health to enter into a personal services contract with Cereatha Boyd for WIC Immunization Technical Services; authorizing payment therefore; and declaring an emergency.

ORD. NO. 607-2007 authorizing the Director of Health to file a grant application and enter into an agreement with the Ohio Commission on Minority Health for funding to establish and operate a Local Office of Minority Health; authorizing the Director of Health to enter into contracts to implement the grant; and declaring an emergency.

ORD. NO. 608-2007 accepting a utility easement for property described below in the City of Akron, for the WEST MARKET STREET project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 609-2007 authorizing the Director of Health to enter into an agreement with the Mansfield-Ontario-Richland County Health Department to provide disease intervention services to clients; and declaring an emergency.

ORD. NO. 610-2007 authorizing the Director of Public Service to enter into an agreement with Akron Energy Systems LLC to operate the steam plant and other heating and cooling facilities owned by the City on an interim basis; authorizing payment therefore; and declaring an emergency.

ORD. NO. 611-2007 authorizing the Director of Public Service to enter into an agreement with the Ohio Director of Transportation for the resurfacing and improvement of Wilbeth Road, Triplett Boulevard, Massillon Road, and George Washington Boulevard and minor bridge work to the Wilbeth Road Structure; and declaring an emergency.

ORD. NO. 612-2007 authorizing the Director of Public Service to enter into an agreement with the Ohio Director of Transportation for the design and construction of improvements to replace worn and damaged signage along the Innerbelt; and declaring an emergency.

NO. 613-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for construction of a new parking deck expansion to the existing Superblock Parking Deck, including improvements to the existing deck and elevators, plus the installation of permanent foundations within the Dart Avenue right of way; approving specifications therefore; and declaring an emergency.
