

## ORDINANCES AND RESOLUTIONS PASSED DECEMBER 17, 2007

**ORD. NO. 637-2007** authorizing the Mayor to enter into a contract, after publicly advertising for bids, of the purchase of real and personal property insurance and boiler and machinery insurance coverage for all City properties for the period of March 1, 2008 to March 1, 2013; approving specifications therefore; and declaring an emergency.

**ORD. NO. 638-2007** accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the NORTH PORTAGE PATH SIDEWALK/ROADWAY IMPROVEMENTS project; authorizing payment therefore; and declaring an emergency.

**RES. NO. 639-2007** approving and confirming the appointments of Donald Plusquellic, Richard Merolla, Warren Woolford, Gerald Egan, Councilwoman Renee Greene, Councilman Bruce Kilby, and Councilman Michael Williams for the year 2008 as members of the Northeast Ohio Four County Regional Planning and Development Organization; and declaring an emergency.

**ORD. NO. 640-2007** authorizing the Director of Public Service to execute an easement with The East Ohio Gas Company dba Dominion East Ohio to provide for a natural gas pipeline; and declaring an emergency.

**ORD. NO. 641-2007** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the purchase of fifteen (15) concrete street light poles and seventeen (17) steel bracket arms; approving specifications therefore; and declaring an emergency.

**ORD. NO. 642-2007** accepting a utility easement for property described below in the City of Akron, for the WEST MARKET STREET project; authorizing payment therefore; and declaring an emergency.
