

## ORDINANCES AND RESOLUTIONS PASSED MARCH 24, 2008

**ORD. NO. 142-2008** authorizing the Director of Finance to pay \$3,732.00, representing the proceeds from the Chriskindl Market Carousel, to Akron Children's Hospital; and declaring an emergency.

**ORD. NO. 143-2008** authorizing the Purchasing Agent to enter into an agreement with Norstan Communication, Inc., for second level maintenance for city wide voice and data systems; and declaring an emergency.

**ORD. NO. 144-2008** accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the N. HAWKINS AVENUE PAVEMENT REPAIR PROJECT; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 145-2008** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the purchase of tools, labor, supervision, and miscellaneous materials to remove and reinstall a headwork screen at the Water Pollution Control Station; approving specifications therefore; and declaring an emergency.

**ORD. NO. 146-2008** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the purchase of one or more entrance gates and operators at the Water Pollution Control Station; approving specifications therefore; and declaring an emergency.

**ORD. NO. 147-2008** amending and/or supplementing Ordinance No. 501-2007, which approved the sale of City owned land, approximately 20 acres, located in Ascot Industrial Park to Bath Woods, LLC by changing the purchase price; and declaring an emergency.

**ORD. NO. 148-2008** amending and/or supplementing Title 5, Chapter 52, Section 52.14 "Service Charge" of the Code of Ordinances to modify curbside collection fees; and declaring an emergency.

**ORD. NO. 149-2008** authorizing a Conditional Use to establish a Child Day Care Business Center at 1129 Kinzie Avenue; and declaring an emergency.

**ORD. NO. 150-2008** authorizing the Director of Public Service to execute, on behalf of the City, an oil and/or gas lease agreement for the mineral rights of 2.62 acres of street right-of-way along Deering Drive, Dewitt Drive, Manderley Drive, Stonewood Drive and Winhurst Drive to Everflow Eastern Partners, L.P. for the "Stan Hywet Unit No. 5" gas/oil well unitization; and declaring an emergency.

**ORD. NO. 151-2008** authorizing the Director of the Department of Planning and Urban Development to enter into a contract with non-profit organizations for the provision of public services in order to carry out the intent and purpose of programs under the Consolidated Plan for the year 2008; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 152-2008** declaring the necessity of, determining to proceed with, and levying special assessments for the improvement of certain streets in the City by constructing, reconstructing and repairing concrete sidewalks and driveway approaches; installing roof drain pipes; and, as necessary, constructing and reconstructing curbs; all in accordance with petitions submitted by property owners under the 2007 City-Wide Sidewalk Program; and declaring an emergency.

**ORD. NO. 153-2008** authorizing the Mayor to apply for and enter into an agreement for Violence Against Women Act grant funds administered by the office of Criminal Justice Services; authorizing the Director of Law to enter into a contract to implement the grant; and declaring an emergency.

**RES. NO. 154-2008** expressing support for Building Ohio Jobs, the \$1.7 billion job stimulus package proposed by Governor Strickland that will create more than 80,000 jobs in Ohio and lay the foundation for long-term economic prosperity in Ohio.
