

ORDINANCES AND RESOLUTIONS PASSED APRIL 14, 2008

ORD. NO. 181-2008 authorizing the Purchasing Agent to enter into a contract, after publicly advertising for bids, for the maintenance of emergency power generating equipment at various City of Akron locations; approving specifications therefore; and declaring an emergency.

ORD. NO. 182-2008 authorizing the Mayor to enter into a contract with professional dance companies and necessary contractors and specialty consultants to provide the Heinz Poll Summer Dance Festival to be held at various locations during the summer of 2008; authorizing payment therefore; and declaring an emergency.

ORD. NO. 183-2008 authorizing the Mayor to enter into a contract with the Akron/Summit Convention & Visitors Bureau for the operation of the convention bureau in 2008; authorizing payment therefore; and declaring an emergency.

ORD. NO. 184-2008 providing for the issuance and sale of a note in the principal amount of \$415,500, in anticipation of the issuance of bonds to pay the property owners' portion, in anticipation of the levy and collection of special assessments, of the cost of improving White Pond Drive between the termini of the Wheeling and Lake Erie Railroad track crossing and 500 feet north of Mull Avenue by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches and storm sewers; installing roof drain pipes; installing traffic signalization and street lighting; and planting trees; and declaring an emergency.

ORD. NO. 185-2008 providing for the issuance and sale of a note in the principal amount of \$287,300, in anticipation of the issuance of bonds to pay the property owners' portion, in anticipation of the levy and collection of special assessments, of the cost of improving North Portage Path between the termini of Mark Drive and Barcelona Drive by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches and storm sewers; installing roof drain pipes; and planting trees; and declaring an emergency.

ORD. NO. 186-2008 providing for the issuance and sale of a note in the principal amount of \$35,200, in anticipation of the issuance of bonds to pay the property owners' portion, in anticipation of the levy and collection of special assessments, of the cost of improving West Market Street between the termini of Waldorf Drive and Bryden Drive by relocating overhead utilities underground; and declaring an emergency.

ORD. NO. 187-2008 authorizing the Director of the Department of Planning and Urban Development to enter into a contract with non-profit neighborhood based organizations for the provision of services in order to carry out the intent and purpose of the Neighborhood Partnership Program; authorizing payment therefore; and declaring an emergency.

ORD. NO. 188-2008 authorizing a Conditional Use to permit the construction of a condominium development on the north side of Smith Road, west of Sourek Trail; and declaring an emergency.

ORD. NO. 189-2008 authorizing a Conditional Use to permit the construction of the East/Goodyear Community Learning Center at 80 Brittain Road; and declaring an emergency.

ORD. NO. 190-2008 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the purchase and/or lease of various equipment in the Public Safety and Health departments; approving specifications therefore; and declaring an emergency.

ORD. NO. 191-2008 authorizing the Mayor to apply for and enter into an agreement for the FY 2008 Bulletproof Vest Partnership Grant administered by the United States Bureau of Justice Assistance; and declaring an emergency.

ORD. NO. 192-2008 authorizing the Mayor to file an application and enter into a grant agreement for funding from the U. S. Department of Homeland Security Assistance to Firefighters Program and to enter into a contract to implement the grant agreement; authorizing the expenditure of local matching funds; and declaring an emergency.
