

## ORDINANCES AND RESOLUTIONS PASSED MAY 5, 2008

**ORD. NO. 225-2008** authorizing the Director of Finance to pay \$60,000 as an operating subsidy for the 2008 All-American Soap Box Derby; and declaring an emergency.

**ORD. NO. 226-2008** accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the FIRST ENERGY WESTSIDE CAMPUS project; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 227-2008** authorizing the expenditure of funds to implement the 2008 Lock 3 Summer Arts Experience and Neighborhood Canvas Project; authorizing the Mayor to enter into contracts for professional services required for these programs; authorizing payment therefore; and declaring an emergency.

**RES. NO. 228-2008** approving, with modification, the renewal application of Donald E. Bessemer to have agricultural property on St. Michaels Avenue continue to be included in an "agricultural district" pursuant to Revised Code Section 929.01, *et seq.*; and declaring an emergency.

**ORD. NO. 229-2008** providing for the issuance and sale of a note in the principal amount of \$47,500, in anticipation of the issuance of bonds to pay the property owners' portion, in anticipation of the levy and collection of special assessments, of the cost of improving Dresden Avenue between the termini of South Firestone Boulevard and Brown Street by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches, and storm sewers; installing roof drain pipes; and planting trees; and declaring an emergency.

**ORD. NO. 230-2008** authorizing the Director of Public Service to request proposals for and enter into a contract for the removal and replacement of the roof of Building 5 at the Municipal Service Center; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 231-2008** levying special assessments for the improvement of 9<sup>th</sup> Street SW and certain other streets between certain termini (2007 Phase I Arterial/Collector Resurfacing Program) by resurfacing such streets with asphaltic concrete 402/404; and declaring an emergency.

**ORD. NO. 232-2008** levying special assessments for the improvement of Cromwell Drive and certain other streets between certain termini (2007 Phase I Partial Depth Pavement Replacement Program) by repaving such streets with asphaltic concrete 402/404; and declaring an emergency.

**ORD. NO. 233-2008** levying special assessments for the improvement of Bannock Street and certain other streets between certain termini (2007 Phase I Residential Resurfacing Program) by resurfacing such streets with asphaltic concrete 402/404; and declaring an emergency.

**ORD. NO. 234-2008** levying special assessments for the improvement of Hilbish Avenue and certain other streets between certain termini (2007 Phase I Unimproved Street

Resurfacing Program) by treating the surface thereof with substances designed to preserve the surface; and declaring an emergency.

**ORD. NO. 235-2008** levying special assessments for the improvement of Albrecht Avenue and certain other streets between certain termini (2006 Phase I Micro-Paving Program) by repaving such streets by the method known as “micro-paving”; and declaring an emergency.
