## ORDINANCES AND RESOLUTIONS PASSED FEBRUARY 9, 2009

- **ORD. NO. 60-2009** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction and installation of a key card entry system in certain areas of the buildings at 177 S. Broadway Street and 368 S. Main Street; approving specifications therefore; and declaring an emergency.
- **ORD. NO. 61-2009** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for certain waste hauling and disposal services; approving specifications therefore; and declaring an emergency.
- **ORD. NO. 62-2009** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for presort mailing service; approving specifications therefore; and declaring an emergency.
- **ORD. NO. 63-2009** authorizing the Director of Public Service to enter into a conditional service agreement with Vesper Lake Bible Fellowship, Inc. to provide Akron water service to the property at 3535 Knollwood Lane in Bath Township; and declaring an emergency.
- **RES. NO. 64-2009** adopting the 2009 Capital Investment and Community Development Program, also known as the Capital Investment Budget; and declaring an emergency.
- **ORD. NO. 65-2009** authorizing the Director of Public Service to enter into an asset purchase agreement with the Copley Square Holding Company; and declaring an emergency.
- **ORD. NO. 66-2009** authorizing a Conditional Use to place skyline level wall signage at 50 South Main Street; and declaring an emergency.
- **ORD. NO. 67-2009** authorizing a Conditional Use to permit the construction of the Hyre Community Learning Center at 2443 Wedgewood Drive; and declaring an emergency.
- **ORD. NO. 68-2009** amending/supplementing Title 15, Chapter 153, "Zoning Code", Section 153.280 "Retail Business Use Districts-Class U3", Section 153.385 "Outdoor Advertising", Section 153.464 "Uses permitted as conditional uses", and Section 153.476 "Special standards applicable to specific conditional uses" of the Code of Ordinances of the City of Akron, by removing and eliminating "outdoor advertising display, billboard and highway advertising device" as a permitted use in a "Retail Business Use District-class U3" and by adding outdoor advertising displays" to the list of uses permitted as conditional uses; and declaring an emergency.
- **ORD. NO. 69-2009** approving the sale of city-owned land located on the north side of Reid Terrace to Mount Zion Baptist Church; determining said property is not needed for public use; and declaring an emergency.

**ORD. NO. 70-2009** authorizing the Mayor to file an application with the State of Ohio, Department of Development, Neighborhood Stabilization Program for the allocation of NSP funds and to enter into an agreement or agreements with the State of Ohio; and declaring an emergency

**ORD. NO. 71-2009** amending Title 13, Chapter 131, Section 131.08 "Criminal Trespass" of the Code of Ordinances of the City of Akron to enhance the penalty for Criminal Trespass for offenders with previous conviction; and declaring an emergency.
