## **ORDINANCES AND RESOLUTIONS PASSED JULY 12, 2010**

- **ORD. NO. 224-2010** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of three replacement roofs on buildings at the Akron Water Plant; approving specifications therefore; and declaring an emergency.
- **ORD. NO. 225-2010** authorizing a Conditional Use to construct a telecommunications tower at 928 Sand Run Road; and declaring an emergency.
- **ORD. NO. 226-2010** authorizing a Conditional Use to expand the parking lot at the Ghent Road Park & Ride facility at the northwest corner of Sourek Road and Ghent Road; and declaring an emergency.
- **ORD. NO. 227-2010** authorizing a Conditional Use to construct a rehabilitation hospital at the northeast corner of East Market Street and North Adams Street; and declaring an emergency.
- **ORD. NO. 228-2010** authorizing the expenditure of \$25,000 and an agreement with Akron Development Corp. to assist in the production of "25 Hill", a film about the All-American Soap Box Derby; and declaring an emergency.
- **ORD. NO. 229-2010** approving the transfer of City owned land to Westside Neighborhood Development Corporation; determining said property is not needed for public use; and declaring an emergency.
- **ORD. NO. 230-2010** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the replacement of a bridge over the Springfield Lake Outlet, including relocation of a water main to accommodate the bridge and other roadway improvements, approving specifications therefore; and declaring an emergency.
- **ORD. NO. 231-2010** declaring the necessity of determining to proceed with, and levying special assessments for the improvement of 560 North Main Street in the City of Akron by repairing and reconstructing storm sewers, curbs, sidewalks and appurtenances thereto; all in accordance with a petition submitted by the property owner of 560 North Main Street; and declaring an emergency.
- **ORD. NO. 232-2010** determining to proceed with the improvement and levying special assessments of various off-street parking facilities known as the Kenmore Business District et al. including the Canton Road parking facility by sealing, resurfacing and repairing, painting parking space stripes, sweeping, removing snow, cleaning sewer openings, providing lawn, turf, shrub and tree maintenance, litter and other general clean-up and otherwise improving and maintaining the same, and all when and where necessary; and declaring an emergency.

NO. 235-2010** authorizing the Mayor to file an application and enter into a contract with the U.S. Department of Transportation for Tiger II funding for the design and construction of the Main Street/Broadway Street Interchange; authorizing the expenditure of local funds in support of the grant; and declaring an emergency.

NO. 236-2010** authorizing the Mayor to file an application and enter into a contract with the Ohio Department of Transportation (ODOT) for TRAC funding for the design and construction of the Main Street/Broadway Street Interchange; authorizing the expenditures of local funds in support of the grant; and declaring an emergency.

NO. 237-2010** authorizing the Director of Finance to donate \$10,000 to Guardians Against Sex Predators ("G.A.S.P.") to help improve child safety by helping to find missing/abducted children, assisting local law enforcement in predator-related initiatives and projects, and educating the community on ways to recognize and prevent child abuse by sexual predators; and declaring an emergency.
