

ORDINANCES AND RESOLUTIONS PASSED JUNE 3, 2013

ORD. NO. 159-2013 authorizing the Director of Finance to pay \$60,000 as an operating subsidy for the 2013 International Soap Box Derby; and declaring an emergency.

ORD. NO. 160-2013 authorizing the Director of the Department of Planning and Urban Development to enter into contracts with non-profit organizations, for the provision of public services in order to carry out the intent and purpose of programs under the Consolidated Plan for the year 2013; and declaring an emergency.

ORD. NO. 161-2013 approving the sale of City owned land to Carol Bloom and Dorothy L. Hayes; determining said property is not needed for public use; and declaring an emergency.

ORD. NO. 162-2013 authorizing the purchase of, and accepting the donation of, property for the Highland Square Grocery Store Project; and declaring an emergency.

ORD. NO. 163-2013 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for construction of the Logan Parkway sanitary sewer extension; approving specifications therefore; and declaring an emergency.

ORD. NO. 164-2013 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for construction of public improvements associated with the 401 Lofts development; approving specifications therefore; and declaring an emergency.

ORD. NO. 165-2013 authorizing the issuance and sale of notes of the City in the maximum principal amount of \$5,000,000 under Section 13 of Article VIII of the Constitution of the State of Ohio and Chapter 165 of the Ohio Revised Code to assist in financing a portion of the costs of a "project" as defined in Section 165.01 of the Ohio Revised Code, for the purpose of creating or preserving jobs and employment opportunities and improving the economic welfare of the people of the City and of the State of Ohio; and declaring an emergency.

ORD. NO. 166-2013 providing for the execution of a Contract for Loan Guarantee Assistance and the issuance of a promissory note in favor of the Department of Housing and Urban Development, in an amount not to exceed \$1,300,000 to refinance the outstanding promissory note issued in favor of the Department of Housing and Urban Development in connection with the development of the Middlebury Grocery and Retail Development Project; and declaring an emergency.

ORD. NO. 167-2013 approving the sale of City owned land to East Akron Neighborhood Development Corp and Akron Zoological Park; determining said property is not needed for public use; and declaring an emergency.

ORD. NO. 168-2013 authorizing the assignment of a lease agreement with purchase option to A. Schulman, Inc.; authorizing the extension of the lease agreement pending exercise of the purchase option; and declaring an emergency.

ORD. NO. 169-2013 determining to proceed with the improvement of Firestone Parkway between the termini of Wilbeth Road and Firestone Boulevard and Firestone Boulevard between the termini of Firestone Parkway and South Main Street by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches, storm sewers and sanitary sewers; installing street lighting; and planting trees; and declaring an emergency.
