ORDINANCES AND RESOLUTIONS PASSED MAY 19, 2014:

ORD. NO. 142-2014 authorizing the Director of the Department of Planning and Urban Development to enter into a contract or contracts with non-profit organizations, for the provision of public services in order to carry out the intent and purpose of programs under the Consolidated Plan for the year 2014; and declaring an emergency. *VOTE: 12-0 (Neal abstained)*

ORD. NO. 143-2014 approving the sale of vacant land on Princeton Street to Hilltop Seven Trust; determining the property is not needed for public use; and declaring an emergency. *VOTE: 12-0 (Neal abstained)*

ORD. NO. 144-2014 approving the sale of vacant land on Ruth Avenue to Iula A. Butler and vacant land at 65 E. Mapledale Avenue to David B. & Amanda K. Skinner; determining the property is not needed for public use; and declaring an emergency. *VOTE: 12-0 (Neal abstained)*

ORD. NO. 145-2014 accepting various right-of-way documents for certain properties on East Market Street and Brittain Road to facilitate the completion of the Brittain Road Bridge Project; authorizing payment therefor; and declaring an emergency. *VOTE: 12-0 (Neal abstained)*

ORD. NO. 146-2014 authorizing the Purchasing Agent, without the formality of advertising for bids, to enter into a contract with Ohio Materials Handling Company for the purchase of a refurbished forklift truck for use by the Water Distribution Division; and declaring an emergency. *VOTE: 12-0 (Neal abstained)*

ORD. NO. 147-2014 authorizing a Conditional Use to install a projecting sign at 300 South Main Street; and declaring an emergency. *VOTE: 13-0*

ORD. NO. 148-2014 authorizing a Conditional Use to construct campus signage at One Perkins Square; and declaring an emergency. *VOTE: 13-0*

ORD. NO. 149-2014 authorizing a Conditional Use to construct an oversized garage at 1432 Fawler Avenue; and declaring an emergency. *VOTE: 13-0*

ORD. NO. 150-2014 amending and/or supplementing Title 11 "Business Regulations," Chapter 111 "Regulations Governing Specific Businesses," to include provisions to regulate food trucks; and declaring an emergency. *VOTE: 13-0*

ORD. NO. 151-2014 authorizing the Mayor to file applications and enter into grant agreements with the Summit County Land Reutilization Corporation for funds to obtain real property; authorizing the acceptance of any grant funds awarded for the acquisition of real property; authorizing the acquisition of real property; and declaring an emergency. *VOTE: 13-0*
