## ORDINANCES AND RESOLUTIONS PASSED OCTOBER 27, 2014:

**ORD. NO. 323-2014** approving the sale of City-owned land to Top Gun Development Corporation and Community Friends Church, determining said property is not needed for public use; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 324-2014** authorizing the Mayor to file an application with assurances and certifications with the U.S. Department of Housing and Urban Development for the Supportive Housing Program for Stewart B. McKinney funds for the homeless; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 325-2014** accepting property by donation for the Summit/Dudley Demonstration Program; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 326-2014** approving the donation of City-owned land to Rebuilding Together Greater Cuyahoga Valley; determining said property is not needed for public use; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 327-2014** approving the sale of 73 Massillon Rd.; determining said property is not needed for public use; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 328-2014** approving and authorizing the execution of an option agreement and a purchase agreement with Famous Enterprises, Inc. or its designee, providing for the sale of City-owned property; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 329-2014** ratifying the actions of the Director of Public Service in entering into a contract with H.M Miller Construction Company for the emergency repair of the sanitary and storm sewers on North Johns Avenue between East Market Street and Mary Avenue; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 330-2014** authorizing the Purchasing Agent, without the formality of advertising for bids, to enter into a contract with Logos Communications, Inc. for the purchase of an upgraded phone system for the Akron Water Plant; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 331-2014** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for miscellaneous improvements to the Akron Water Plant; approving specifications therefore; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 332-2014** authorizing the Director of Public Service to enter into a contract with Akron Tractor and Equipment, Inc. for the purchase of one utility vehicle for the Water Supply Bureau; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 333-2014** authorizing the Mayor to enter into a contract with the Interval Brotherhood Home to provide comprehensive residential drug and alcohol treatment to eligible individuals; and declaring an emergency. *VOTE: 12-0 (Omobien abstained)*

**ORD. NO. 334-2014** amending Ordinance No. 75-2014, passed March 17, 2014 and Ordinance No. 210-2014, passed July 14, 2014, which established the annual appropriation for the current expenses, other expenditures and the capital outlays of the City of Akron for the fiscal year ending December 31, 2014 and declaring an emergency. ***VOTE: 13-0***
