



# CITY OF AKRON, OHIO

## ORDINANCES AND RESOLUTIONS PASSED MAY 11, 2015:

**ORD. NO. 133-2015** approving and authorizing the execution of a Contract for Sale of Land for Private Redevelopment with Akron White Pond Building Associates, LLC, or its designee, (“Redeveloper”), providing for the sale of property on White Pond Drive for redevelopment pursuant to the White Pond-Frank Urban Renewal Plan; finding such property is not needed for any public use, and related findings; and declaring an emergency. *VOTE: 13-0*

**ORD. NO. 134-2015** ratifying the actions of the Director of Public Service in entering into a contract with Canal Construction Company for the emergency repair of settled sidewalk and pavement at 324 West Market Street; and declaring an emergency. *VOTE: 13-0*

**ORD. NO. 135-2015** authorizing the Mayor to enter into a reimbursement agreement to assist Ultra Tech Machinery, Inc. in creating jobs within the City of Akron; and declaring an emergency. *VOTE: 13-0*

**ORD. NO. 136-2015** authorizing a Conditional Use to construct a parking lot at 1206 California Avenue; and declaring an emergency. *VOTE: 13-0*

**ORD. NO. 137-2015** approving the sale of City-owned land located at 1206 California Avenue to Ronald G. Kerns, dba Panyard, Inc., determining said property is not needed for public use; and declaring an emergency. *VOTE: 13-0*

**ORD. NO. 138-2015** authorizing the Director of the Department of Planning and Urban Development to enter into a contract or contracts with non-profit neighborhood-based organizations for the provision of services in order to carry out the intent and purpose of the Neighborhood Partnership Program; authorizing payment therefore; and declaring an emergency. *VOTE: 12-0 (Neal abstained)*

**RES. NO. 139-2015** amending Resolution No. 31-2015, which adopted the 2015 Capital Investment Budget, to reflect additional funds for street resurfacing improvements; and declaring an emergency. *VOTE: 13-0*

**ORD. NO. 140-2015** authorizing the Director of Public Service to enter into contracts using Community University Education Purchasing Association (CUE) bids, National Joint Powers Association (NJPA) bids or State of Ohio bids, or after publicly advertising for bids, for the purchase and/or lease of various equipment used in daily operations of the Department of Public Service; approving specifications therefor; and declaring an emergency. *VOTE: 13-0*

**ORD. NO. 141-2015** authorizing the Director of Public Service to enter into an agreement with the Ohio Director of Transportation for the sealing of various bridges; and declaring an emergency. *VOTE: 13-0*
