ORDINANCES AND RESOLUTIONS PASSED NOVEMBER 2, 2015:

ORD. NO. 334-2015 approving the sale of 0.08 acres of City-owned land located at 179 Oak Park Drive (PN 67-31508), determining said property is not needed for public use; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 335-2015 approving the sale of 0.21 acres of City-owned land located at 158 Edgerton Road, determining said property is not needed for public use; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 336-2015 approving the sale of City-owned land on Andrus St. to Angela Perdue and 5th Ave. to East Akron Neighborhood Development Corporation; determining said property is not needed for public use; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 337-2015 accepting property on Stetler Avenue by donation for the C.D. Land Banking Project; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 338-2015 authorizing the Director of Public Service to enter into an agreement with the Ohio Department of Transportation for crack sealing on U.S. Route 224; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 339-2015 ratifying the actions of the Director of Public Service in entering into a contract with Stanovic Roofing, without the formality of advertising for bids, for the emergency repair and replacement of the roof at Fire Station No. 6; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 340-2015 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, through the Office of the Purchasing Agent, for the replacement of the roof of the Laboratory Building at the Water Reclamation Facility; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 341-2015 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, through the Office of the Purchasing Agent, for miscellaneous repairs to the parking lot at the Water Reclamation Facility; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 342-2015 authorizing the Purchasing Agent to enter into contracts for the lease of five vehicles for use by the Special Narcotics Uniform Detail (SNUD) Bureau of the Akron Police Department; and declaring it an emergency. **VOTE: 12-0**

ORD. NO. 343-2015 authorizing the Mayor to negotiate, execute and deliver a Cooperative Agreement, a Lease-Purchase Agreement and related documents with the County of Summit relating to the acquisition, maintenance and operation of the APCO Project 25 radio system; and declaring an emergency. **VOTE: 12-0**

RES. NO. 344-2015 approving and confirming the appointments of Anita Davis and Larry Poulos to the Board of Review; and declaring an emergency. **VOTE: 12-0**

ORD. NO. 345-2015 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the replacement of fifty broken or damaged fire hydrants throughout the City; approving specifications therefore; and declaring an emergency. **VOTE: 12-0**

RES. NO. 346-2015 expressing support for the Intimate Partner Violence Bill, to be introduced in the Ohio House of Representatives, which will expand the protections and legal options for unmarried victims of domestic violence who are in a serious romantic relationship with their abuser, in order to deter and reduce domestic violence and abuse in all Ohio communities; and declaring an emergency. **VOTE: 12-0**
