- **ORD. NO. 355-2015** authorizing the Director of Finance to pay costs associated with the City's participation in miscellaneous organizations, associations and agencies; and declaring an emergency. **VOTE:** 12-0
- **ORD. NO. 356-2015** authorizing the purchase of 224 Mustill Ct. for the Ohio Canal Interceptor Tunnel Project; and declaring an emergency. **VOTE: 12-0**
- **RES. NO. 357-2015** approving and confirming the appointments of Teresa LeGrair and Julie Ann Sweet to the City Planning Commission; and declaring an emergency. **VOTE: 12-0**
- **ORD. NO. 358-2015** approving the sale of City-owned land on Berwin Street; determining said property is not needed for public use; and declaring an emergency. **VOTE: 12-0**
- **ORD. NO. 359-2015** approving and confirming the appointments of Councilmen Mike Freeman and Donnie Kammer to the Board of Directors of the Coventry-Akron, Springfield-Akron, Bath-Akron-Fairlawn, and Copley-Akron Joint Economic Development Districts; and declaring an emergency. **VOTE: 12-0**

- **ORD. NO. 362-2015** authorizing the Mayor, the Director of Public Service, the Director of Finance, the Director of Law, the Director of Planning and/or the Director of Neighborhood Assistance, through the office of the Purchasing Agent, without the formality of advertising for bids, to purchase miscellaneous supplies and repair parts and labor for machinery and equipment used by various divisions and departments of the City for a period of one (1) year; authorizing payment therefore; and declaring an emergency. **VOTE:** 12-0
