- **ORD. NO. 356-2016** authorizing the purchase of a sewer easement for the CSO Rack 36 Sewer Separation Project; and declaring an emergency. *VOTE: 12-0*
- **ORD. NO. 357-2016** authorizing the transfer of City-owned property on Sumner and Allyn Streets to Akron Public Schools in exchange for property owned by said Akron Public Schools on Carnegie, Manchester and Beaver Street; and declaring an emergency. *VOTE: 12-0*
- **ORD. NO. 358-2016** declaring certain improvements to real property located in the Downtown Redevelopment Area to be a public purpose and exempt from real property taxation; providing for the collection of service payments in lieu of taxes and the deposit of those service payments in the appropriate fund; providing for the payment of a portion of the service payments to the Akron Public School District, all pursuant to Ohio Revised Code Sections 5709.41 to 5709.43 (the "Act"); and declaring an emergency. (100 Rosa Parks Drive) *VOTE: 12-0*
- **ORD. NO. 359-2016** declaring certain improvements to real property located in the Highland Square Urban Renewal Redevelopment Area to be a public purpose and exempt from real property taxation; providing for the collection of service payments in lieu of taxes and the deposit of those service payments in the appropriate fund; providing for the payment of a portion of the service payments to the Akron Public School District, all pursuant to Ohio Revised Code Sections 5709.41 to 5709.43 (the "Act"); and declaring an emergency. - **ORD. NO. 360-2016** declaring certain improvements to real property located in the Arlington/Kelly Urban Renewal Area to be a public purpose and exempt from real property taxation; providing for the collection of service payments in lieu of taxes and the deposit of those service payments in the appropriate fund; providing for the payment of a portion of the service payments to the Akron Public School District, all pursuant to Ohio Revised Code Sections 5709.41 to 5709.43 (the "Act"); and declaring an emergency. **VOTE: 12-0**
- **ORD. NO. 361-2016** ratifying the actions of the Director of Public Service in entering into a contract with Workman Industrial Services, Inc. for the necessary repair of a leaking water main located at the Akron Water Plant; and declaring an emergency. *VOTE: 12-0*
- **ORD. NO. 362-2016** authorizing the Director of Finance to enter into an agreement with The University of Akron School of Law to provide an amount not to exceed \$25,000 for its expungement program; and declaring an emergency. *VOTE: 12-0*
