ORDINANCES AND RESOLUTIONS PASSED APRIL 17, 2017:

RES. NO. 106-2017 declaring the necessity and intent of the City of Akron to appropriate fee simple interests in real property owned by Aaron and Louise Bane under a land contract with John Richards, Jr., located 454 Wellington Avenue, for the purposes of constructing, maintaining, repairing, enlarging, and reconstructing a sewer or sewers and waterlines for drainage, sewerage and waterline purposes in connection with the Hazel Street Storage Basin Project (CSO Racks 10/11); and declaring an emergency. **VOTE: 12-0 (Neal abstained)**

RES. NO. 107-2017 declaring the necessity and intent of the City of Akron to appropriate fee simple interests in real property owned by Jeannette Bray, David Maddox, Margaret Parmis, Lawrence Maddox, and Leonard Maddox, located at 246 Eastland Avenue, for the purposes of constructing, maintaining, repairing, enlarging, and reconstructing a sewer or sewers and waterlines for drainage, sewerage and waterline purposes in connection with the Hazel Street Storage Basin Project (CSO Racks 10/11); and declaring an emergency. **VOTE: 12-0 (Neal abstained)**

RES. NO. 108-2017 declaring the necessity and intent of the City of Akron to appropriate fee simple interests in real property owned by Charlie Harris, located at 436 Wellington Avenue, for the purposes of constructing, maintaining, repairing, enlarging, and reconstructing a sewer or sewers and waterlines for drainage, sewerage and waterline purposes in connection with the Hazel Street Storage Basin Project (CSO Racks 10/11); and declaring an emergency. **VOTE: 12-0 (Neal abstained)**

ORD. NO. 109-2017 authorizing the Director of Public Service to enter into contracts using Community University Education Purchasing Association (CUE) bids, National Joint Powers Association (NJPA) bids or State of Ohio bids, or after publicly advertising for bids, for the purchase and/or lease of various vehicles and/or equipment used in the daily operations of the Departments of Public Service, Public Safety, and Neighborhood Assistance in 2017; approving specifications therefore; and declaring an emergency. **VOTE: 12-0 (Neal abstained)**

ORD. NO. 110-2017 authorizing the Purchasing Agent, after publicly advertising for bids, to enter into a contract for the purchase of 50 additional sets of fire protective clothing for the Akron Fire Division; and declaring an emergency. **VOTE: 12-0 (Neal abstained)**

RES. NO. 111-2017 congratulating and honoring St. Vincent-St. Mary Boys Basketball Team (“The Fighting Irish”) and their coaches on capturing the Division II State Basketball Championship; and declaring an emergency. **VOTE: 13-0**

ORD. NO. 112-2017 authorizing the issuance of a bond of the City in a principal amount not to exceed \$10,000,000 for sale to the Water Pollution Control Loan Fund of the State of Ohio to finance the costs of improvements to the City’s wastewater system; pledging certain revenues from the City’s

wastewater system on a subordinated basis to secure the payment of the principal of and interest on the Bond; and authorizing the execution and delivery of the Bond, the Trust Agreement and other documents and the taking of other actions related to the issuance and sale of the Bond; and declaring an emergency. ***VOTE: 13-0***

RES. NO. 113-2017 recognizing and honoring the life and achievements of Diana Zaleski; and declaring an emergency. ***VOTE: 13-0***
