**BUDGET & FINANCE:**

1. ORDINANCE authorizing the Director of Finance, through the office of the Purchasing Agent, without the formality of publicly advertising for bids, to enter into a contract for the purchase of postage from the U.S. Postal Service for use by the Akron Municipal Clerk of Courts; and declaring an emergency.

**PLANNING:**

2. ORDINANCE authorizing a Conditional Use to establish a child day care business center at 543 Fillmore Avenue; and declaring an emergency. *Public Hearing scheduled for 7/3/17*

3. ORDINANCE authorizing a Conditional Use to establish a medical marijuana cultivation and processing site at 171 Kelly Avenue; and declaring an emergency. *Public Hearing scheduled for 6/26/17*
