BUDGET & FINANCE:

1. ORDINANCE amending Ordinance No. 42-2017, passed February 13, 2017, which established the annual appropriation for the current expenses, other expenditures and the capital outlays of the City of Akron for the fiscal year ending December 31, 2017 and declaring an emergency
2. ORDINANCE amending and/or supplementing Ordinance No. 198-2014, authorizing the Director of Finance to enter into an agreement or agreements with authorized service providers to provide additional deferred compensation investment options to City employees; to select and remove additional financial institutions as investment options from time to time; and declaring an emergency.
3. ORDINANCE authorizing the Clerk of the Akron Municipal Court to enter into a contract, without the formality of advertising for bids, with Mapsys, Inc. for the purpose of providing upgrades the office's operating system; and declaring an emergency.

PLANNING:

4. ORDINANCE approving the donation of a City-owned property; determining said property is not needed for public use; and declaring an emergency.
5. ORDINANCE approving the donation of City owned land; determining the property is not needed for public use; and declaring an emergency.
6. ORDINANCE approving the sale of a vacant City-owned properties pursuant to the City's "A Lot for A Little" Program; determining said properties are not needed for public use; and declaring an emergency.
7. ORDINANCE authorizing the Mayor to file an application with assurances and certifications with the U.S. Department of Housing and Urban Development for the Continuum of Care Application for Stewart B. McKinney funds for the homeless; and declaring an emergency.

PUBLIC SERVICE:

8. ORDINANCE ratifying the actions of the Director of Public Service in the emergency repair of the elevators in the Superblock Parking Deck; and declaring an emergency.

9. ORDINANCE authorizing the Purchasing Agent, after publicly advertising for bids, to enter into a contract or contracts for the purchase of LED lighting fixtures for the Cascade Parking Deck; and declaring an emergency.

- 9A ORDINANCE determining to proceed with the improvement of South Main Street between the termini of State Street and Mill Street by paving; grading; constructing and reconstructing curbs, concrete sidewalks, storm sewers, sanitary sewers, water mains, and utility vaults; installing street lighting and planting trees; and declaring an emergency.

PUBLIC SAFETY:

10. ORDINANCE authorizing the Mayor to accept the Fire Prevention and Safety Grant from the Department of Homeland Security; authorizing the expenditure of matching funds; and declaring an emergency.

11. RESOLUTION opposing and objecting to the application of Hibachi Express Ohio, LLC, 456 E. Exchange Street, Akron Ohio 44304 for a Class D5 and D6 liquor permit (9598200) now pending before the Division of Liquor Control; and declaring an emergency. This application is a request for transfer of ownership of a permit at the above listed location.
