### ORDINANCES & RESOLUTIONS PASSED 10-23-17

Ord 338-2017 authorizing the Purchasing Agent, without the formality of advertising for bids, to enter into a contract or contracts with Whitespace for the redesign of the Akron Municipal Court website, the amount of which is not to exceed \$30,000; and declaring an emergency. VOTE 12-0

Ord 339-2017 authorizing the Director of the Department of Planning and Urban Development to enter into an agreement or agreements with the Urban Neighborhood Development Corporation (UNDC) to provide for the construction and sale of moderate cost single-family homes on a non-profit basis within the Community Development Activity Area; authorizing payment therefore; and declaring an emergency. VOTE 12-0

ORD 340-2017 authorizing the Director of Public Service to enter into a Cooperation Agreement with AT&T; and declaring an emergency. VOTE 12-0

ORD 341-2017 ratifying the actions of the Director of Public Service, through the office of the Purchasing Agent, in entering into a contract with Sulzer Pump Services Inc. for the emergency removal, inspection, repair, and re-installation of two currently inoperable vertical turbine pumps at the Akron Water Plant; and declaring an emergency. VOTE 12-0

ORD 342-2017 authorizing the Director of Public Service, through the office of the Purchasing Agent, without the formality of advertising for bids, to enter into a contract with EMP Power & Water Solutions, Inc. for the purchase of Ovation Controllers to upgrade existing controllers during the Step Feed Improvement Project at the Water Reclamation Facility; and declaring an emergency. VOTE 12-0

ORD 343-2017 authorizing the Mayor or his designee to apply for and to accept, if awarded, funding from the Northern Ohio Golf Charities, Inc. grant program; and declaring an emergency. VOTE 12-0

ORD 344-2017 amending/supplementing Title 7 “Traffic Code,” Chapter 76 “Parking Regulations,” Article 1, “Generally,” of the Akron Codified Ordinances to amend Section 76.30 “Handicapped Parking”; and declaring an emergency. VOTE 12-0

ORD 345-2017 authorizing the City to donate an easement interest in City property to Children’s Hospital Medical Center of Akron; and declaring an emergency. VOTE 12-0

ORD 346-2017 authorizing the Purchasing Agent, without the formality of publicly advertising for bids, to enter into a contract with the Best Equipment Company for the purchase of a used Mach Leach rear loading paper truck; and declaring an emergency. VOTE 12-0
