ORDINANCES & RESOLUTIONS PASSED 10-30-17

- 1 ORD 347-2017 directing the appropriation of a fee simple interest in real property owned by Martha M. Nelson, located at 1052 Hazel Street, for the purposes of constructing, maintaining, repairing, enlarging, and reconstructing a sewer or sewers and waterlines for drainage, sewerage and waterline purposes in connection with the Hazel Street Storage Basin Project (CSO Racks 10/11); declaring the intention of the City of Akron to proceed under Ohio Revised Code Section 163.06(A) and Article 1; Section 19 of the Ohio Constitution for the appropriation of real property due to a public exigency; and declaring an emergency. VOTE 12-0

- 2 RES 348-2017 declaring the necessity and intent of the City of Akron to appropriate fee simple interests in real property owned by Connie Riley, Thomas Simpkins, and the Estate of Chappie Murphy, located at 1152 5th Avenue, for the purposes of constructing, maintaining, repairing, enlarging, and reconstructing a sewer or sewers and waterlines for drainage, sewerage and waterline purposes in connection with the CSO Rack 3 Kelly Green Project; and declaring an emergency. VOTE 12-0

- 3 RES 349-2017 declaring the necessity and intent of the City of Akron to appropriate fee simple interests in real property owned by David A. White, located at 1166 5th Avenue, for the purposes of constructing, maintaining, repairing, enlarging, and reconstructing a sewer or sewers and waterlines for drainage, sewerage and waterline purposes in connection with the CSO Rack 3 Kelly Green Project; and declaring an emergency. VOTE 12-0

- 4 ORD 350-2017 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bid, for maintenance of expressway lighting on various portions of expressways and bridges located within the City; approving specifications therefor; and declaring an emergency. VOTE 12-0

- 5 ORD 351-2017 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the installation of a fire suppression system in the control room of the SCADA and network upgrades at the the Akron Water Plant; and declaring an emergency. VOTE 12-0

- 6 RES 352-2017 recognizing the dedication, service and sacrifice of those individuals serving in or on behalf of the United States' Armed Services who have been wounded or killed in combat; reaffirming Akron's commitment to honor those who faithfully serve and who have served in defense of the United States of America; designating the City of Akron a "Purple Heart City"; and declaring an emergency. VOTE 12-0
