<u>BUDGET & FINANCE</u>

1. ORDINANCE amending/supplementing Title 9 "General Provisions," Chapter 104 "Income Tax Ordinance," Section 104.03 "Purposes of tax; rate" in order to update the Codified Ordinances of the City of Akron to reflect the additional 0.25% income tax levied pursuant to Section 86e of the Charter of the City of Akron, as approved by the voters on November 7, 2017; and declaring an emergency.

PLANNING

- 2. ORDINANCE declaring certain improvements to real property located in the White Pond Frank Blvd Urban Renewal Area to be a public purpose and exempt from real property taxation, providing for the collection of service payments in lieu of taxes and the deposit of those service payments in the appropriate fund, providing for the payment of a portion of said service payments to the Akron Public School District, all pursuant to Ohio Revised Code Sections 5709.41 to 5709.43 (the "Act"); and declaring an emergency.
- 3. ORDINANCE authorizing the City to grant an easement interest in City property to Cleveland Clinic/Akron General Hospital; and declaring an emergency.
- 4. RESOLUTION declaring the necessity and intent of the City of Akron to appropriate fee simple interests in real property owned by Noah Zalewski, located at 408 Wellington Avenue, for the purposes of constructing, maintaining, repairing, enlarging, and reconstructing a sewer or sewers and waterlines for drainage, sewerage and waterline purposes in connection with the Hazel Street Storage Basin Project (CSO Racks 10/11); and declaring an emergency.
- 5. ORDINANCE declaring improvements to certain real property located in the Eastgate II Urban Redevelopment Area to be a public purpose and exempt from real property taxation; declaring that construction and rehabilitation of certain real property is a public purpose; providing for the collection of service payments in lieu of taxes and the deposit of those service payments in the Urban Redevelopment Tax Increment Equivalent Fund; providing for the payment of a portion of said service payments to the Akron Public School District; and declaring an emergency.
- 6. ORDINANCE authorizing the execution of a Contract for Sale of Land for Private Redevelopment with East Akron Neighborhood Development Corporation and EANDC Middlebury LLC, or their respective assignees; providing for the acquisition, sale and redevelopment of property in the Amended

Middlebury Urban Renewal Plan Area; finding that such property is not needed for any public use, and related findings and declaring an emergency.

PUBLIC SERVICE

- 7. ORDINANCE authorizing the Mayor, the Director of Public Service, the Director of Finance, and the Director of Neighborhood Assistance to enter into contracts, after publicly advertising for bids, for the purchase of materials and services needed by the various divisions and departments of the City for a period of time not to exceed 3 years; approving the specifications therefor; and declaring an emergency.
- 8. ORDINANCE appointing and approving the Assessment Equalization Board Member List; and declaring an emergency.

PUBLIC UTILITIES

9. ORDINANCE authorizing the Director of Public Service, without the formality of publicly advertising for bids, to enter into a contract for the replacement of the water transmission main beneath State Route 43 at Ravenna Road in Kent, Ohio; and declaring an emergency.

PUBLIC SAFETY

- 10. ORDINANCE amending/supplementing Title 7 "Traffic Code," Chapter 70 "General Provisions," Article 4 "Impounding," Section 70.52 "Motor vehicle pounds" in order to add two towing companies to the City's towing districts; and declaring an emergency.
- 11. ORDINANCE authorizing the Purchasing Agent to enter into a contract or contracts, after publicly advertising for bids, for needed repairs and improvements to kitchen facilities in two of the City's fire stations, in accordance with the 2017 Capital Improvement Plan; and declaring an emergency.

PARKS & RECREATION

12. RESOLUTION congratulating and honoring the 2017 East CLC football team and their coaches on winning the Akron City Series Football Championship; and declaring an emergency.

HEALTH & SOCIAL SERVICE

13. RESOLUTION opposing the tax bill recently passed by the United States Senate, urging the President to veto any such legislation that comes before him, urging the President to shield Medicare, Medicaid, and Social Security from any cuts; and declaring an emergency.

ECONOMIC DEVELOPMENT

14. ORDINANCE authorizing the Mayor or his designee to enter into a grant agreement with Rogers Industrial Products, Inc.; and declaring an emergency.
