ORDINANCES & RESOLUTIONS PASSED APRIL 16, 2016

- 1 ORD 115-2018 repealing Ordinance No. 306-2003 passed by this Council on June 9, 2003 and authorizing the Mayor to execute a Release of Mortgage; and declaring an emergency. VOTE 13-0

- 2 ORD 116-2018 authorizing the Purchasing Agent, without the formality of publicly advertising for bids, to enter into a contract with Bearing Distributors, Inc. for the purchase of three Nord primary tank gearboxes; and declaring an emergency. VOTE 13-0

- 3 ORD 117-2018 authorizing the Purchasing Agent, without the formality of publicly advertising for bids, to enter into a contract with Sulzer Pump Services Inc. for additional repairs on four (4) vertical turbine pumps at the Akron Water Plant; and declaring an emergency. VOTE 13-0

- 4 ORD 118-2018 amending/supplementing Title 15, Chapter 153, "Zoning Code", Section 153.578 "Subdivision of Uses in the UPD-40 district" by updating development requirements; and declaring an emergency. VOTE 13-0

- 5 ORD 119-2018 amending The Zoning Map by changing the Single Family Residential Use District Classification (U1, H1, A1) on property located on the west side of Hall Street, and property located on the east side of Hall Street, addressed as 190 South Maple Street, and 144 to 122 Bittman Street to a UPD-40 District Classification; and declaring an emergency. VOTE 13-0

- 6 ORD 120-2018 amending The Zoning Map by changing the Apartment House Use District Classification (U2, H2, A4) on property in the block bounded by South Maple Street on the west, Glendale Avenue on the south, and the east and west sides of South Walnut Street to a UPD-40b District Classification; and declaring an emergency. VOTE 13-0

- 7 ORD 121-2018 authorizing a Conditional Use to establish child day care business center at 340 Ira Avenue; and declaring an emergency. VOTE 13-0

- 8 ORD 122-2018 authorizing a Conditional Use to establish child day care business center at 937 Dover Avenue; and declaring an emergency. VOTE 13-0

- 9 ORD 123-2018 amending/supplementing Title 13, "General Offenses," Chapter 130 "General Provisions," Section 130.02 "Definitions" and Title 13 "General Offenses," Chapter 139 "Miscellaneous," Section 139.09 "Illegal distribution of cigarettes or other tobacco products" of the Codified Ordinances of the City of Akron to prohibit the sale of cigarettes, other tobacco products, and tobacco product paraphernalia to individuals under the age of twenty-one; authorizing a contract with the Summit County Combined General Health District to implement these provisions through regulations; and declaring an emergency. (3/19/18) (SUBSTITUTE OFFERED AS AN AMENDMENT - read in 4/2/18) VOTE 8-3 (Hoch, Kammer, Keith) (Sims, Samples Abstained)

- 10 ORD 124-2018 authorizing the Director of Public Service to enter into a contract or contracts, after publicly advertising for bids, for the purchase and application of asphaltic concrete, pavement removal, and riser rings for various streets in the 2018 Arterial Collector Streets Resurfacing Program, including alternates; approving specifications therefor; and declaring an emergency. VOTE 13-0

- 11 ORD 125-2018 authorizing the Director of Public Service to enter into a contract or contracts, after publicly advertising for bids, for the purchase and application of asphaltic concrete, pavement removal, and riser rings for various streets in the 2018 Residential Streets Resurfacing Program, including alternates; approving specifications therefor; and declaring an emergency. VOTE 13-0

- 12 ORD 126-2018 authorizing the Director of Public Service to enter into a contract or contracts, after publicly advertising for bids, for the purchase and application of asphaltic concrete, pavement removal and riser rings for various streets in the 2018 Unimproved Streets Resurfacing Program, including alternates; approving specifications therefor; and declaring an emergency. VOTE 13-0

- 13 ORD 127-2018 authorizing the Director of Neighborhood Assistance to enter into a contract with the Northeast Ohio Basketball Association for the management, promotion and operation of the Dru Joyce Classic; and declaring an emergency. VOTE 13-0
