ORDINANCES & RESOLUTIONS PASSED 4/23/2018

- 1 ORD 128-2018 authorizing the Director of Public Service to enter into an LPA agreement with the Ohio Director of Transportation for the Safe Routes to School 2018 Program; and declaring an emergency. VOTE 12-0 (Sims Absent)

- 2 ORD 129-2018 authorizing the Mayor to apply for and accept, if awarded, a grant from the Gertrude F. Orr Trust Advised Fund of Akron Community Foundation to cover printing expenses associated with Marsy's Law; and declaring an emergency. VOTE 12-0 (Sims Absent)

- 3 ORD 130-2018 authorizing the Mayor to enter into a contract with Oriana House, Inc. for confinement, rehabilitation services and alternative sentencing options for certain offenders convicted of violations of the Akron Municipal Code; and declaring an emergency. VOTE 12-0 (Sims Absent)

- 4 RES 131-2018 opposing the addition of a citizenship question to the 2020 decennial Census questionnaire; urging adequate funding for the Census Bureau and increased in-person follow-up census counts; directing the clerk to forward a copy of this resolution; and declaring an emergency. VOTE 8-4 (Freeman, Hoch, Kammer, Keith) (Sims Absent)

- 5 ORD 132-2018 authorizing the Mayor or his designee to apply for and accept grant funding through the 2018 Wells Fargo and U.S. Conference of Mayors Community WINS Grant Program to be utilized for funding financial counseling services at the Akron Financial Empowerment Center; authorizing the Mayor or his designee to enter into related agreements; and declaring an emergency. VOTE 12-0 (Sims Absent)

- 6 ORD 133-2018 approving the sale of city owned land to Sweet & Buntin Real Estate Properties, LLC; determining said property is not needed for public use; and declaring an emergency. VOTE 12-0 (Sims Absent)

- 7 RES 134-2018 expressing support for the development of State and National bicycle routes; requesting that the American Association of State Highway and Transportation Officials and the Ohio Department of Transportation finalize and approve certain bicycle routes in and around the City of Akron; and declaring an emergency. VOTE 12-0 (Sims Absent)

- 8 ORD 135-2018 authorizing the Purchasing Agent, after publicly advertising for bids, to enter into a contract for the purchase of ten (10) thermal imaging units for use by the Akron Fire Department; and declaring an emergency. VOTE 12-0 (Sims Absent)
