ORDINANCES & RESOLUTIONS PASSED JULY 9, 2018

- 1 ORD 231-2018 authorizing the Director of Public Service or his designee, without the formality of publicly advertising for bids, to enter into a contract or contracts with S.A. Comunale Co., Inc. for the maintenance of the fire sprinkler system in Canal Park Stadium; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 2 ORD 232-20118 authorizing the Director of Public Service, or his designee, to pay the insurance deductible to Kenworth of Canton for repairing the damage to an automated side-loading refuse-collection truck; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 3 ORD 233-2018 authorizing the Mayor to file applications and enter into agreements with the Ohio EPA and Ohio Water Development Authority for a Water Pollution Control Loan to fund the construction of the Uhler Conveyance (CSO Rack 27 and 29) Project; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 4 ORD 234-2018 authorizing the Purchasing Agent, or her designee, after publicly advertising bids, to enter into contracts with a vendor for the purchase of 20-inch valve gearbox assemblies for large-diameter valves for use in the City's water supply system; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 5 ORD 235-2018 authorizing the Mayor, or his designee, to file applications and enter into an agreement or agreements with the Ohio Environmental Protection Agency for funding through the Water Supply Revolving Loan Account program to assist the City in financing the State Route 43 Water Main Crossing Replacement; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 6 ORD 236-2018 authorizing the Director of Public Service, or his designee, to enter into a contract or contracts, after publicly advertising for bids through the Office of the Purchasing Agent, for the purchase of two grit screws and troughs for the Water Reclamation Facility; approving specifications therefor; and declaring an emergency. VOTE 12-0 (Sommerville absent)

- 7 ORD 237-2018 authorizing the Purchasing Agent, after publicly advertising for bids, to enter into a contract or contracts with various vendors for the purchase of water meters, meter parts, and meter-reading parts; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 8 ORD 238-2018 authorizing the Director of Public Service or his designee, after publicly advertising for bids, to enter into a contract or contracts for the purchase of copper tubing, curb boxes, and shut-off valves for water service to be installed at certain water mains throughout the City; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 9 ORD 239-2018 ratifying the actions of the Director of Public Service in contracting with Kenmore Construction Company, Inc. for the emergency repair and reconstruction of a 36-inch water main on West North Street beneath the railroad tracks; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 10 ORD 240-2018 authorizing the Mayor or his designee to enter into an agreement with the County of Summit for the provision of Direct Indictment Services; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 11 ORD 241-2018 authorizing a Conditional Use to establish a child day care business center at 348 Pioneer Street; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 12 ORD 242-2018 authorizing the Mayor, or his designee, without the formality of publicly advertising for bids, to enter into contracts with Burgess Ambulance Sales, Inc. to provide for the refurbishment of one emergency medical unit; and declaring an emergency. VOTE 12-0 (Sommerville absent)
