### ORDINANCES & RESOLUTIONS PASSED JULY 23, 2018

- 1 ORD 255-2018 approving the sale of certain vacant City-owned properties at 202/204 (VL) E. Miller Avenue pursuant to the City's "A Lot for A Little" Program, in order to facilitate the productive re-use of the property and to reduce the cost to the City and the taxpayers in maintaining vacant lots; determining said property is not needed for public use; and declaring an emergency. (Substitute offered as an Amendment) VOTE 13-0
- 2 ORD 256-2018 approving the 2018 Consolidated Action Plan including applications and certifications for the Community Development Block Grant ("Community Development"), the HOME Investment Partnership ("HOME") and Emergency Solutions Grant ("ESG") Programs; authorizing the Director of Planning and Urban Development to enter into all necessary contracts for the operation and term of the Programs; and declaring an emergency. VOTE 13-0
- 3 ORD 257-2018 authorizing the Mayor to accept a grant award for the Akron PeaceMakers Project funded through the U.S. Conference of Mayor's DollarWise: Mayor's for Financial Literacy Initiative; authorizing expenditure of funds on identified programs to promote financial literacy; and declaring an emergency. (\$10,000 grant, no match). VOTE 13-0
- 4 ORD 258-2018 authorizing the Purchasing Agent to enter into a contract, without the formality of advertising for bids, for back-up software for the Citywide Data Center from Software House International Corporation; and declaring an emergency. VOTE 13-0
- 5 ORD 259-2018 accepting a vacation plat for a portion of Pine Alley; and declaring an emergency. VOTE 13-0
- 6 ORD 260-2018 approving the sale of City-owned land located at 132 Willard Avenue; finding that the land is not needed for public purpose; and declaring an emergency. VOTE 13-0
- 7 ORD 261-2018 levying special assessments for the improvement of

Kingswood Drive between the termini of Merriman Road and Rocky Hollow Drive, and Rocky Hollow Drive between the termini of Kingswood Drive and Rocky Ridge Drive by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches, storm sewers and water mains; installing roof drain pipes; and planting trees, all together with the necessary appurtenances; and declaring an emergency. VOTE 13-0

- 8 ORD 262-2018 levying special assessments for the improvement of Wilbeth Road between the termini of Dallas Avenue and Interstate 77 by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches, storm sewers and water mains; installing roof drain pipes; and planting trees, all together with the necessary appurtenances; and declaring an emergency. VOTE 13-0
- 9 ORD 263-2018 authorizing the Director of Public Service or his designee, after publicly advertising for bids, to enter into a contract or contracts to construct Eckert Ditch water-quality improvements; and declaring an emergency. VOTE 13-0
- 10 ORD 264-2018 authorizing the Mayor or his designee to enter into agreements with various political subdivisions in the County of Summit for the provision of Prosecutorial Services; and declaring an emergency. VOTE 13-0
- 11 ORD 265-2018 authorizing a Conditional Use to retain a solid fence at 1250 Brown Street; and declaring an emergency. VOTE 13-0
- 12 ORD 266-2018 amending/supplementing Title 9 “General Provisions,” Chapter 98 “Streets and Sidewalks” to enact Article 10 “Management, Administration and Control of the Use of the City’s Public Rights-Of-Way” in order to implement comprehensive regulations governing access to and placement of facilities and structures within the City of Akron’s rights-of-way; and declaring an emergency. (Substitute Offered as an Amendment) VOTE 13-0
- 13 ORD 267-2018 levying special assessments for the improvement of Firestone Parkway between the termini of Wilbeth Road and Firestone Boulevard and Firestone Boulevard between the termini of Firestone Parkway and South Main Street by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches, storm sewers and sanitary sewers; installing street lighting; and planting trees; and declaring an emergency. VOTE 13-0
- 14 ORD 268-2018 levying special assessments for the improvement of Wilbeth Road between the termini of Manchester Road and Dallas

Avenue by paving; grading; resurfacing; constructing and reconstructing curbs, concrete sidewalks and driveway approaches; installing roof drain pipes and street lighting; and planting trees, all together with the necessary appurtenances thereto; and declaring an emergency. VOTE 13-0

- 15 ORD 269-2018 levying special assessments for the improvement of Englewood Avenue between the termini of Wigley Street and Massillon Road by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches, sanitary sewers, storm sewers, and water mains; installing water service connections, sanitary sewer house laterals, and roof drain pipes; and declaring an emergency. VOTE 13-0
- 16 ORD 270-2018 levying special assessments for the improvement of Seiberling Way and Eagle Street between certain termini by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches, storm sewers, sanitary sewers, sanitary sewer house laterals, water mains and water service connections; installing street lighting; and planting trees, all together with the necessary appurtenances; and declaring an emergency. VOTE 13-0
- 17 ORD 271-2018 authorizing the Purchasing Agent, after publicly advertising for bids, to enter into a contract or contracts for the purchase fire protective clothing for use by the Akron Fire Department; and declaring an emergency. VOTE 13-0
- 18 RES 272-2018 opposing and objecting to the renewal applications of Baho Corporation, D/B/A 7-11 Store #56645, 460 W. Market Street, Akron, Ohio 44308 for a Class C1 and C2 liquor permit (0370186) now pending before the Division of Liquor Control; and declaring an emergency. VOTE 13-0
- 19 RES 273-2018 opposing and objecting to the renewal applications of CGC Entertainment, LLC, D/B/A Clutch Gentlemen's Club, 1890 S. Arlington Street, Akron, Ohio 44306 for a Class D5 and D6 liquor permit (1376999) now pending before the Division of Liquor Control; and declaring an emergency. VOTE 13-0
- 20 ORD 274-2018 approving the amendment to the Petition for Special Assessments for Special Energy Improvement Projects under Ohio Revised Code Chapter 1710; approving the amendment to the City of Akron, Ohio Energy Special Improvement District Project Plan; amending special assessments levied by the City of Akron, Ohio, and declaring an emergency.
