PLANNING

- Ordinance authorizing the execution of a development agreement with Mayflower Manor Apartments Ohio LP, and Mayflower Manor Apartments LLC; providing for the acquisition, sale and redevelopment of property in the Downtown Redevelopment Plan Area; finding such property is not needed for any public use, and related findings; and declaring an emergency.
- Ordinance authorizing the Mayor to execute and deliver a
 Cooperative Agreement related to the establishment of the Firestone
 Business Park; authorizing the sale of certain real property of the City,
 such property being no longer needed for public use; and declaring an
 emergency.

PUBLIC SERVICE
