

## **ORDINANCES AND RESOLUTIONS PASSED MAY 19, 2008**

**ORD. NO. 254-2008** authorizing the Director of Public Service to grant an air rights easement to AkroChem (Akron Chemical Company) precluding, for the life of the structure, the erection of any building or structure on the westerly 20 feet of City-owned land adjacent to the AkroChem property at 255 Fountain Street; and declaring an emergency.

**ORD. NO. 255-2008** approving the change in location of Greg's Towing and amending and/or supplementing Title 7, Chapter 70, Section 70.52 " Motor Vehicle Pounds" to reflect this approval; and declaring an emergency.

**ORD. NO. 256-2008** authorizing a Conditional Use to permit the construction of a parking lot for a medical building at 916 East Waterloo Road; and declaring an emergency.

**ORD. NO. 257-2008** authorizing a Conditional Use to operate an auto repair business at 320 East Cuyahoga Falls Avenue; and declaring an emergency.

**ORD. NO. 258-2008** approving an amendment to the Redevelopment Plan for the Ascot Urban Redevelopment Area; and declaring an emergency.

**ORD. NO. 259-2008** authorizing the Mayor to enter into an agreement with The University of Akron Foundation for a grant in the amount of \$50,000.00 for the creation of a business plan for the Akron Academic Health Center; and declaring an emergency.

**ORD. NO. 260-2008** providing for the issuance and sale of \$2,600,000 of notes, in anticipation of the issuance of bonds, for the purpose of paying costs of improving the municipal parks and recreational system by constructing, improving and equipping parks and recreational facilities including Elizabeth Park, Towpath Trails and Canal Locks 3 and 4 and other park and recreational facilities designated or to be designated by the Director of Public Service, constructing and equipping related basketball and tennis courts, parking lots, utilities pedestrian walkways and bridges, lighting and bikeways and making site and other improvements, all where necessary and as applicable and together with all necessary appurtenances thereto; and declaring an emergency.

**ORD. NO. 261-2008** providing for the issuance and sale of \$4,900, 000 of notes, in anticipation of the issuance of bonds, for the purpose of paying costs of improving White Pond Drive, Kirn Street and certain other streets and properties in the City, including such improvements relating to the Elizabeth Park Hope VI, Spicertown, Legacy and West Akron development projects, all in accordance with plans prepared by the city Engineer, by constructing, reconstructing, widening, paving, grading, draining, resurfacing, constructing curbs, sidewalks and driveway approaches, constructing water lines, sanitary sewers and storm sewers, water service connections and sanitary sewer laterals, installing signalization and lighting, landscaping, installing fire hydrants, retaining walls and guard rails and otherwise improving the same, all where necessary and as applicable and together with all necessary appurtenances thereto; and declaring an emergency.

**RES. NO. 262-2008** declaring it necessary to improve various off-street parking facilities in the Kenmore Business District and the Canton Road Business District by sealing, resurfacing and repairing, painting parking space stripes, sweeping, removing snow, cleaning sewer openings, providing law, turf, shrub and tree maintenance, litter and other general clean-up and otherwise improving and maintaining the same, and all when and where necessary; and declaring an emergency.

**ORD. NO. 263-2008** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the repair and relocation of existing sanitary sewers on East Miller Avenue and Bellows Street; approving specifications therefore; and declaring an emergency.

**ORD. NO. 264-2008** authorizing the Mayor to enter into an agreement with the Summit County Historical Society for the operation of the Akron History Museum at Lock 3 Park during 2008; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 265-2008** authorizing the Director of Health to enter into an agreement with the International Institute to provide interpreter services for health screenings and related referrals; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 266-2008** amending and/or supplementing Ordinance No. 887-1969, passed on November 18, 1969, which authorized a Conditional Use to permit, with limitations and conditions, the expansion of existing beverage distribution facilities on property at 1030-1076 Palmetto Avenue by changing the name and address of the owner and condition (6) regarding access to Palmetto Avenue; and declaring an emergency.

**ORD. NO. 267-2008** accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the BIO MEDICAL CORRIDOR project; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 268-2008** authorizing the Mayor to enter into a grant agreement with the Ohio Department of Development for funding from the Roadwork Development Grant for use in funding the roadway improvements on White Pond Drive in support of the First Energy project and the new West Side Office Park; authorizing payment therefore; and declaring an emergency.
