

**ORDINANCES AND RESOLUTIONS PASSED SEPTEMBER 29, 2008**

**ORD. NO. 438-2008** authorizing the Director of Public Service to enter into a contract with Ohio Pavement Systems, Inc. to test a new asphalt rejuvenator product; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 439-2008** authorizing the Purchasing Agent to conduct a public auction on the internet of surplus artwork donated to the City to raise funds for the 2008 Akron Arts Expo; and declaring an emergency.

**ORD. NO. 440-2008** authorizing a Conditional Use to permit the installation of projecting signs on property at 22 East Exchange Street; and declaring an emergency.

**ORD. NO. 441-2008** accepting a sewer easement for property described below in the City of Akron; authorizing payment therefore; authorizing the assignment of said easement; and declaring an emergency.

**ORD. NO. 442-2008** endorsing the Revolving Loan Fund Plan Certification as required by the U. S. Economic Development Administration; and declaring an emergency.

**ORD. NO. 443-2008** authorizing the Mayor to establish a Small Business Assistance Program to assist eligible business applicants in areas of construction of City of Akron public improvements and to enter into contracts with such businesses; and declaring an emergency.

**ORD. NO. 444-2008** authorizing the Mayor to enter into a contract with the Butch Reynolds Care for Kids Foundation for the implementation of after-school and summer programs; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 445-2008** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for construction of improvements, including carpeting, HVAC, lighting and power, to the sixth floor and additional exhaust hoods and counters on the eighth floor, at the Akron Global Business Accelerator; approving specifications therefore; and declaring an emergency.

**ORD. NO. 446-2008** authorizing the Mayor and Director of Public Service to place all of the affected employees of the Sewer Division into other divisions and departments of the City at the same hourly pay at such time as the sewer system is leased to provide scholarships to Akron resident students; and declaring an emergency.

**ORD. NO. 447-2008** authorizing the Mayor to file an application and enter into an agreement with the State of Ohio, Department of Development, for funding from the Clean Ohio Assistance Fund for the environmental assessment of Goodyear property on the north and south sides of Archwood Avenue known as the Chemical division property in the Goodyear Redevelopment Project Area, in the City of Akron; and if funding is awarded, to enter into an agreement to implement the assessment; and declaring an emergency.

**ORD. NO. 448-2008** declaring certain improvements to real property located in the Ascot Urban Redevelopment Area to be a public purpose and exempt from real property taxation, providing for the collection of service payments in lieu of taxes, providing for the payment of a portion of said service payments to the Woodridge Local School District, establishing the Ascot Industrial Park Redevelopment Tax Increment Equivalent Fund (JZM Properties), all pursuant to Ohio Revised Code Sections 5709.41 to 5709.43 (the "Act"); and declaring an emergency.
