

## **ORDINANCES AND RESOLUTIONS PASSED OCTOBER 20, 2008**

**ORD. NO. 461-2008** declaring support for and contributing Five Thousand Dollars to the Mayors for Peace 2020 Vision Campaign to eliminate all nuclear weapons by the year 2020; and declaring an emergency.

**ORD. NO. 462-2008** amending and/or supplementing Ordinance No. 1113-1993, passed March 1, 1993, which authorized a Conditional Use to permit the construction of a retail store on property at 1634 Brittain Road by changing the name and address of the owner; and declaring an emergency.

**ORD. NO. 463-2008** amending and/or supplementing Ordinance No. 886-1988, passed November 7, 1988, which authorized a Conditional Use to permit the construction of additions to an existing school on property at 707 Schocalog Road by changing the name and address of the school operator; and declaring an emergency.

**ORD. NO. 464-2008** accepting conveyance(s) by deed of estate in fee simple of property in the City of Akron, for the HICKORY CORRIDOR URBAN RENEWAL AREA project; authorizing payment therefore; and declaring an emergency.

**RES. NO. 465-2008** approving and confirming the appointment of John B. Nicholas to the Urban Design and Historic Preservation Commission; and declaring an emergency.

**ORD. NO. 466-2008** declaring certain improvements to real property located in the O'Neil's Urban Renewal Area to be a public purpose and exempt from real property taxation, providing for the collection of service payments in lieu of taxes, providing for the payment of a portion of said service payments to the Akron Public School District, and establishing the O'Neils Urban Renewal Area Redevelopment Tax Increment Equivalent Fund (219 South Main Street), all pursuant to Ohio Revised Code Sections 5709.41 to 5709.43 (the "Act"); and declaring an emergency.

**ORD. NO. 467-2008** authorizing the Director of Finance, to donate \$20,000 to the "Goods for Guns" gun buy-back program scheduled for November 21 and 22, 2008; and declaring an emergency.

**ORD. NO. 468-2008** authorizing the Mayor, the Director of Public Service, the Director of Health, and /or the Director of Finance to purchase miscellaneous supplies and repair parts and labor for machinery and equipment used by various divisions of the departments of the City for a period of one (1) year; authorizing payment therefore; and declaring an emergency.

**RES. NO. 469-2008** Resolution approving and confirming the appointments of Frank Joseph Horn and Jane Startzman to the Urban Design and Historic Preservation Commission; and declaring an emergency.

**RES. NO. 470-2008** urging support of State Issue 5, the referendum on reform of payday lending, which appears on the November 4, 2008 ballot; and declaring an emergency.
