

## **ORDINANCES AND RESOLUTIONS PASSED MARCH 16, 2009**

**ORD. NO. 104-2009** accepting a vacation plat for a section of Edgewood Avenue, at the intersection of Westerly Road; and declaring an emergency.

**ORD. NO. 105-2009** accepting a dedication plat for the extension of Tech Way on the east side of Kelly Avenue, north of East Archwood Avenue a distance of 217.46 feet in length to the east; and declaring an emergency.

**ORD. NO. 106-2009** approving the sale of 2.93 acres of city-owned land located on the south side of Hickory Street, north of West North Street, west of North Walnut Street and east of Tarbell Street to Capital First Development, LLC; determining said property is not needed for public use; and declaring an emergency.

**ORD. NO. 107-2009** authorizing the Mayor to enter into an agreement with the County of Summit and the State of Ohio Department of Transportation for the continuation of a comprehensive transportation planning program for the Akron Metropolitan Area; authorizing the Director of Finance to enter into an agreement for the marketing of the Ohio Rideshare carpooling program; and declaring an emergency.

**RES. NO. 108-2009** approving, with modification, the renewal application of Donald E. and Carol A. Bessemer to have agricultural property at 1543 Collier Road placed in an "agricultural district" pursuant to Revised Code Section 929.01, et seq.; and declaring an emergency.

**RES. NO. 109-2009** approving, with modification, the renewal application of Francis Kunkel to have agricultural property at 1605 Dreisbach Drive placed in an "agricultural district" pursuant to Revised Code Section 929.01, et seq.; and declaring an emergency.

**RES. NO. 110-2009** approving, with modification, the renewal application of Elias and Evelia Gudino to have agricultural property at 1080 St. Michaels Avenue placed in an "agricultural district" pursuant to Revised Code Section 929.01, et seq.; and declaring an emergency.

**ORD. NO. 111-2009** authorizing the Director of Finance to pay \$15,000.00 for an operating subsidy to Cascade Locks Park Association; declaring this expenditure of funds to be in the public interest and for a public purpose; and declaring an emergency.

**ORD. NO. 112-2009** authorizing the Mayor to enter into a contract with the Akron/Summit Convention & Visitors Bureau for the operation of the convention bureau in 2009; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 113-2009** authorizing the Director of Public Service to enter into a contract with Unifilt Corporation for the purchase of material, labor and equipment to replace filter media at the Akron Water Supply Plant; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 114-2009** authorizing the Director of Public Service to enter into a contract, after public advertising for bids, for the purchase of grit screw units for the Water Pollution Control Division; approving specifications therefore; and declaring an emergency.

**ORD. NO. 115-2009** authorizing the Mayor to apply for and enter into a grant agreement for FY 2009 Justice and Mental Health Collaboration Grant funding administered through the Bureau of Justice Assistance to develop and enhance programs to improve and expand the current justice and mental health system; authorizing the expenditure of local matching funds; and declaring an emergency.

**ORD. NO. 116-2009** authorizing the Mayor to enter into an agreement with the United States Department of Justice, Drug Enforcement Administration for the reimbursement of allowable costs for officers who assist in Organized Crime Drug Enforcement Task Force investigations and prosecutions; and declaring an emergency.
