

## **ORDINANCE AND RESOLUTIONS PASSED FEBRUARY 5, 2007:**

ORD. NO. 45-2007 accepting Various Right-of-Way Document(s) for certain property described below to facilitate the completion on the SUM 261 – 11.57 / TALLMADGE AVENUE project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 46-2007 amending and/or supplementing Ordinance No. 749-1998, which amended Ordinance No. 722-1998, which authorized a Conditional Use for a salvage yard on property at 1068 Bank Street by changing the name of the Petitioner and Condition (15) regarding the transfer of the Conditional Use; and declaring an emergency.

ORD. NO. 47-2007 authorizing the Director of Public Service to enter into a contract with a consultant for the design of the Summit Lake Towpath Trail; authorizing payment therefore; and declaring an emergency.

ORD. NO. 48-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of renovations to the Morley Health Center; approving specifications therefore; and declaring an emergency.

ORD. NO. 49-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of renovations to the Kenmore Community Center; approving specifications therefore; and declaring an emergency.

ORD. NO. 50-2007 accepting a vacation plat for a section of Sycamore Street, north of West Dresden Avenue; and declaring an emergency.

ORD. NO. 51-2007 accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the LEGGETT COMMUNITY LEARNING CENTER project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 52-2007 approving and authorizing the execution of a contract for sale for private redevelopment with Akron Legacy Real Estate Development, LLC (“Redeveloper”), providing for the sale and redevelopment of property pursuant to the Market-Union Redevelopment Plan (“Plan”); finding such property is not needed for any public use, and related findings; and declaring an emergency.

ORD. NO. 53-2007 accepting a vacation plat for a portion of South Prospect Street, south of East Market Street; and declaring an emergency.

ORD. NO. 54-2007 authorizing a Conditional Use to permit the establishment of an office and health care facility on property on the south side of East Market Street at South Prospect Street; and declaring an emergency.

ORD. NO. 55-2007 declaring certain improvements to real property located in the Market-Union Redevelopment Area to be a public purpose and exempt from real property taxation, providing for the collection of service payments in lieu of taxes, providing for the payment of a portion of said service payments to the Akron Public School District, establishing the Market Union Redevelopment Area Redevelopment Tax Increment Equivalent Fund (Legacy), all pursuant to Ohio Revised Code Sections 5709.41 to 5709.43 (the “Act”); and declaring an emergency.

ORD. NO. 56-2007 providing for the issuance and sale of \$909,945 of bonds, to pay, in anticipation of the collection of special assessments heretofore levied, the property owners’ portion of the cost of improving certain streets in the City; and declaring an emergency.

RES. NO. 57-2007 Resolution declaring the necessity and intent of the City of Akron to appropriate a fee simple interest and temporary right of way interest in certain real property owned by David Miller, located at 446 East Tallmadge Avenue, for the purposes of making or repairing roads that are open to the public in connection with the SUM 261-11.57 Project; declaring the necessity and intention of the City of Akron to proceed under Ohio Revised Code, Section 163.06(B) for the purpose of making or repairing roads that are open to the public without charge; and declaring an emergency.
