

ORDINANCES AND RESOLUTIONS PASSED MARCH 12, 2007

ORD. NO.101-2007 authorizing the Director of Public Service to enter into a lease with the State of Ohio, Department of Natural Resources, for certain Ohio and Erie Canal Lands, to relocate the existing water main in Waterloo Road beneath the Canal; and declaring an emergency.

ORD. NO. 102-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the purchase of labor, materials, tools and equipment to improve security of doors and windows at the Akron Water Supply Plant; approving specifications therefore; and declaring an emergency.

ORD. NO. 103-2007 approving the sale of City-owned land located at 289 East North Street to the Akron Metropolitan Housing Authority in conjunction with their Hope VI application; determining said property is not needed for public use; and declaring an emergency.

ORD. NO. 104-2007 authorizing the Director of the Department of Planning and Urban Development to enter into a contract or contracts with non-profit organizations for the provision of the public services and housing related activities in order to carry out the intent and purpose of programs under the Consolidated Plan for the year 2007; authorizing payment therefore; and declaring an emergency.

RES. NO. 105-2007 declaring the necessity and intent of the City of Akron to appropriate a fee simple interest in real property owned by Robert Wade, Jr., located at 312 Dean Street, for the purposes of eliminating conditions of blight and preventing the recurrence of blight, facilitating the development of new housing, and furthering the objectives of the Elizabeth Park Urban Renewal Plan; and declaring an emergency.

ORD. NO. 106-2007 declaring the necessity of, determining to proceed with, and levying special assessments for the improvement of certain streets in the City by constructing, reconstructing and repairing concrete sidewalks and driveway approaches; installing roof drain pipes; and, as necessary, constructing and reconstructing curbs, replacing and repairing retaining walls and removing trees; all in accordance with petitions submitted by property owners under the 2006 City-Wide Sidewalk Program; and declaring an emergency.

ORD. NO. 107-2007 ratifying the actions of the Director of Public Service in contracting with Air Comfort, Inc., for emergency installation of new air conditioning units to cool the City's main computers; authorizing payment therefore; and declaring an emergency.

ORD. NO. 108-2007 authorizing the City of Akron to participate in the GSA Auto Choice program to purchase four Ford Expeditions to be used by the Public Safety Divisions; authorizing payment therefore; and declaring an emergency.

ORD. NO. 109-2007 authorizing the Mayor to enter into an agreement with Summit Medina Business Alliance, Inc., to maintain the operations of the Small Business Development Center and provide the cash match for available state funding to support the Small Business Development Center for the 2006-2007 fiscal year; authorizing an expenditure of City funds; and declaring an emergency.

ORD. NO. 110-2007 approving and authorizing the execution of a Ground Lease Agreement with Summa Health System or its designee (the “Redeveloper”), providing for the lease of property with an option to purchase for redevelopment pursuant to the Summa Urban Renewal Plan (“Plan”); finding such property is not needed for any public use, and related findings; and declaring an emergency.
