

## **ORDINANCES AND RESOLUTIONS PASSED MARCH 26, 2007**

ORD. NO. 122-2007 authorizing the Mayor to enter into an agreement with the County of Summit and the State of Ohio Department of Transportation for the continuation of a comprehensive transportation planning program for the Akron Metropolitan Area; authorizing the Director of Finance to enter into an agreement for the marketing of the Ridesharing Program; and declaring an emergency.

ORD. NO. 123-2007 authorizing the Director of Planning and Urban Development to enter into an agreement or agreements for title, appraisal and review appraisal services to carry out the Community Development Program and other programs; and declaring an emergency.

ORD. NO. 124-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of security fencing on public property on Abington Road; approving specifications therefore; and declaring an emergency.

ORD. NO. 125-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of Phase 4 of the Highland Square Redevelopment Project; approving specifications therefore; and declaring an emergency.

ORD. NO. 126-2007 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the labor and equipment to manufacture mulch utilizing the City's collected leaves, wood waste and wood waste gathered by contractors; approving specifications therefore; and declaring an emergency.

RES. NO. 127-2007 adopting an annual operating budget for the fiscal year 2007; and declaring an emergency.

ORD. NO. 128-2007 to make the annual appropriation for the current expenses, other expenditures and the capital outlays of the City of Akron for the fiscal year ending December 31, 2007; and declaring an emergency.

ORD. NO. 129-2007 authorizing the Director of Law to enter into a contract with the Summit County Public Defender Commission to provide legal services for indigent defendants in Akron Municipal Court through the Legal Defenders Office of Summit County, Ohio, Inc.; authorizing payment therefore; and declaring an emergency.

RES. NO. 130-2007 declaring the necessity and intent of the City of Akron to appropriate a fee simple interest and a temporary right-of-way easement in certain real property owned by Narrotam K. Patel and Shushils N. Patel, located at the S.E. corner of E. Tallmadge Avenue and Gorge Boulevard, for the purposes of making or repairing roads that are open to the public in conjunction with the SUM 261-11.57 Project; declaring the necessity and intention of the City of Akron to proceed under Ohio Revised

Code, Section 163.06(B) for the purpose of making or repairing roads that are open to the public without charge; and declaring an emergency.

RES. NO. 131-2007 declaring the necessity and intent of the City of Akron to appropriate a fee simple interest in real property owned by Lance Weimer and Monica Weimer, and located at 339 Cross Street, for the purpose of constructing the Leggett Community Learning Center; and declaring an emergency.

RES. NO. 132-2007 declaring the necessity and intent of the City of Akron to appropriate a fee simple interest, temporary right of way interest and a temporary work agreement easement in certain real property owned by Angelo Simone and JSCG Properties, LLC, located at 590 East Tallmadge Avenue, for the purposes of making or repairing roads that are open to the public in connection with the SUM 261-11.57 Project; declaring the necessity and intention of the City of Akron to proceed under Ohio Revised Code, Section 163.06(B) for the purpose of making or repairing roads that are open to the public without charge; and declaring an emergency.
