

ORDINANCES AND RESOLUTIONS PASSED SEPTEMBER 24, 2007

ORD. NO. 475-2007 authorizing the Mayor to enter into a contract after publicly advertising for bids, for the purchase of upgraded network equipment for the Akron Municipal Court; authorizing payment therefore; and declaring an emergency.

ORD. NO. 476-2007 ratifying the actions of the Director of Public Service in contracting with Kenmore Construction Company for emergency repairs to West Exchange Street; authorizing payment therefore; and declaring an emergency.

ORD. NO. 477-2007 authorizing the Director of Public Service to enter into a contract or contracts, after publicly advertising for bids, for the purchase of a weir gate for the Storm Retention Tank at the Water Pollution Control Station; approving specifications therefore; and declaring an emergency.

ORD. NO. 478-2007 authorizing the Director of Health to enter into an agreement with Ritzman Pharmacies, Inc., for the provision of prescription drug dispensing services to patients of the Akron Health Department; authorizing payment therefore; and declaring an emergency.

ORD. NO. 479-2007 accepting a utility easement for property described below in the City of Akron, for the West Market Street Project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 480-2007 accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the West Market Street Project; authorizing payment therefore; and declaring an emergency.

ORD. NO. 481-2007 amending/supplementing Title 15, Chapter 153, "Zoning Code", Section 153.280 "Retail Business Use Districts-Class U3" and Section 153.285 "Commercial Use Districts-Class U4" of the Code of Ordinances of the City of Akron, by adding "Day Labor Pool Temporary Employment Agency" as a permitted use; and declaring an emergency.

ORD. NO. 482-2007 approving the Summit Akron Solid Waste Management Authority Solid Waste Plan; and declaring an emergency.

ORD. NO. 483-2007 authorizing a Conditional Use to construct an office building at 791 White Pond Drive; and declaring an emergency.

ORD. NO. 484-2007 authorizing the Mayor to submit grant applications and enter into grant agreements with the U. S. Environmental Protection Agency for funding from the Brownfield Assessment Grant Program for the assessment of hazardous materials and petroleum contamination at various sites in the City of Akron; and declaring an emergency.

RES. NO. 485-2007 declaring it necessary to improve Dover Avenue between the termini of Diagonal Road and Stoner Street, East Park Boulevard between the termini of Congo Street and the south end, Genoa Avenue between the termini of Cluster Avenue and East Park Boulevard, and Santee Avenue between the termini of South Arlington Street and Van Everett Avenue by paving; grading; constructing and reconstructing curbs, concrete sidewalks and driveway approaches; and installing roof drain pipes; and declaring an emergency.

ORD. NO. 486-2007 ratifying the actions of the Director of Public Service in contracting with Kenmore Construction Co., Inc., for emergency repairs to bus shelters on South Main Street; authorizing payment therefore; and declaring an emergency.

ORD. NO. 487-2007 authorizing the Director of Public Service to request the Ohio Department of Transportation to add South Martha Avenue and a portion of South Seiberling Street, from Martha Avenue to Triplett Boulevard, to the State Highway System; and declaring an emergency.
