

## **ORDINANCES AND RESOLUTIONS PASSED NOVEMBER 19, 2007**

**ORD. NO. 582-2007** approving the sale of City owned land to Debra A. Calhoun; determining said property is not needed for public use; and declaring an emergency.

**ORD. NO. 583-2007** approving the sale of City owned land to Gerald Modon; determining said property is not needed for public use; and declaring an emergency.

**ORD. NO. 584-2007** approving the sale of city-owned land located on the west side of North Maple Street, south of North Street to Arlington Market Partners, LLC.; determining said property is not needed for public use; and declaring an emergency.

**ORD. NO. 585-2007** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for golf cart concessions at Good Park Golf Course and Mud Run Golf Course; approving specifications therefore; and declaring an emergency.

**ORD. NO. 586-2007** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the removal of trees along Memorial Parkway; approving specifications therefore; and declaring an emergency.

**ORD. NO. 587-2007** accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the EDGEWOOD HOPE VI ROAD IMPROVEMENTS project; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 588-2007** amending and/or supplementing Ordinance No. 414-1995, passed on June 26, 1995, which authorized a Conditional Use to permit the construction of a coffee house on property at 489 Brown Street, by changing the name of the owner; and declaring an emergency.

**ORD. NO. 589-2007** approving the 2008 Consolidated Action Plan including applications and certifications for the Community Development Block Grant (hereinafter Community Development), the HOME Investment Partnership (hereinafter HOME) and Emergency Shelter Grant (hereinafter ESG) Programs; authorizing the Director of Planning and Urban Development to enter into all necessary contracts for the operation and term of the Programs; and declaring an emergency.

**ORD. NO. 590-2007** authorizing the Director of Finance, on behalf of the City, to donate \$10,000 to the "Goods for Guns" gun buy-back program scheduled for December 7<sup>th</sup> and 8<sup>th</sup>, 2007; and declaring an emergency.

**RES. NO. 591-2007** declaring the official intent and reasonable expectation of the City of Akron on behalf of the State of Ohio (borrower) to reimburse its capital fund for the Tallmadge Avenue Widening with the proceeds of tax exempt debt of the State of Ohio; and declaring an emergency.

**ORD. NO. 592-2007** levying special assessments for the improvement of Silver Street between certain termini by paving; grading; constructing and reconstructing curbs, sidewalks, and driveway approaches; installing roof drain pipes and storm and sanitary sewer house laterals; constructing storm sewers; and planting trees; and declaring an emergency.

**ORD. NO. 593-2007** levying special assessments for the improvement of Parkgate Avenue and certain other streets, between certain termini, by paving; grading; constructing and reconstructing curbs, sidewalks and driveway approaches; installing roof drain pipes; installing street lighting; and planting trees; and declaring an emergency.

**ORD. NO. 594-2007** authorizing the Director of Public Service to extend the lease agreement with the YMCA for the CitiCenter Athletic Facility; and declaring an emergency.

**ORD. NO. 595-2007** authorizing the Director of Public Service to purchase five used vehicles at public auction; authorizing payment therefore; authorizing the resale of these vehicles at public auction when they are no longer needed for public use; and declaring an emergency.

**ORD. NO. 596-2007** Ordinance providing for certain declarations and findings as required by Senate Bill 117, (the Statewide Video Franchising Law); and declaring an emergency.

**ORD. NO. 597-2007** authorizing the Director of Public Service to enter into a contract with Taylor Tele-Communications for directional drilling of the Ravenna Road Conduit to relocate the fiber optic line and install a conduit for installation of natural gas service; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 598-2007** authorizing the Mayor to enter into a grant agreement with the Ohio HIDTA to reimburse the City of Akron for the cost of leasing seven (7) vehicles; and declaring an emergency.

**ORD. NO. 599-2007** authorizing the Mayor to enter into a contract, after publicly advertising for bids, for the purchase of five thermal imaging cameras for use in the Fire Division; approving specifications therefore; and declaring an emergency.

**ORD. NO. 600-2007** accepting a waterline easement for property described below for the ALBRECHT AVENUE EDITH WATER JEDD project; authorizing payment therefore; and declaring an emergency.
