

## **ORDINANCES AND RESOLUTIONS PASSED JULY 28, 2008**

**ORD. NO. 377-2008** authorizing the Director of Finance to pay the membership dues for fiscal year 2009 to the Northeast Ohio Four County Regional Planning and Development Organization (NEFCO) in the amount of \$43,415.00; and declaring an emergency.

**ORD. NO. 378-2008** ratifying the actions of the Director of Public Service in contracting with Wingfoot Rental and Development Company for emergency repairs to the sanitary sewer near Falmouth Road; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 379-2008** ratifying the actions of the Director of Public Service in contracting with Cavanaugh Building Corporation for emergency repairs to the Firestone Stadium; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 380-2008** authorizing the Director of Public Service to enter into a contract; after publicly advertising for bids, for the maintenance and repair of the main runway at the Akron Fulton Airport; approving specifications therefore; and declaring an emergency.

**ORD. NO. 381-2008** authorizing the Director of Public Service to enter into a contract for the rental of equipment for the 2008 Leaf Removal Program; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 382-2008** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for miscellaneous piping improvements at the Water Pollution Control Station; approving specifications therefore; and declaring an emergency.

**ORD. NO. 383-2008** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the purchased and installation of two new sluice gates and four new actuators at the Water Supply Plant; approving specifications therefore; and declaring an emergency.

**ORD. NO. 384-2008** authorizing the Director of Health to enter into contracts with the Barberton Health Department and the Summit County Health District to enroll women, infants and children in the Special Supplemental Nutrition Grant Program funded by the Ohio Department of Health; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 385-2008** accepting a dedicated public utility right-of-way plat for land on the west side of White Pond Drive, south of the Akron, Canton & Youngstown Railroad right-of-way and Frank Boulevard, and north of Scudder Drive; and declaring an emergency.

**ORD. NO. 386-2008** authorizing the Mayor to enter into an agreement with the Greater Akron Chamber for economic development activities and business services to be performed in 2008; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 387-2008** authorizing the issuance and sale of not to exceed \$23,500,000 Taxable Economic Development Revenue Bonds, Series 2008, of the City of Akron under

Section 13 of Article VIII of the Constitution of the State of Ohio and Chapter 165 of the Ohio Revised Code to assist in financing a portion of the costs of a “project” as defined in Section 165.01 of the Ohio Revised Code, for the purpose of creating or preserving jobs and employment opportunities and improving the economic welfare of the people of the City and of the State of Ohio, authorizing the signing of a trust indenture, establishing certain funds of the City pursuant thereto; authorizing the signing of a bond purchase agreement and other documents in connection with the issuance and sale of the Bonds; authorizing the signing and distribution of a preliminary and final official statement; and declaring an emergency.

**ORD. NO. 388-2008** determining to proceed with the improvement of Massillon Road between the termini of Oakes Drive and Massillon Service Drive, George Washington Boulevard between the termini of Springfield Lake Boulevard and Triplett Boulevard, Wilbeth Road between the termini of Allendale Avenue and South Arlington Street and Triplett Boulevard between the termini of South Arlington Street and Hilbish Avenue by resurfacing; approving the report of the Assessment Equalization Board; and declaring an emergency.

**ORD. NO. 389-2008** determining to proceed with the improvement of North Street between the termini of North Howard Street and Furnace Street by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches, storm sewers and water mains; installing roof drain pipes and street lighting; and planting trees; approving report of the Assessment Equalization Board; and declaring an emergency.

**ORD. NO. 390-2008** determining to proceed with the improvement of East Market Street between the termini of State Route 59 and Arlington Street by resurfacing; approving the report of the Assessment Equalization Board; and declaring an emergency.

**ORD. NO. 391-2008** amending the Code of Ordinances of the City of Akron to add new Section 139.05 entitled “Notice of Contamination from Methamphetamine Production”; and declaring an emergency.

**ORD. NO. 392-2008** authorizing the Mayor to amend the agreement with H & R Johnson, Inc., dba Henry’s Acme, in order to promote neighborhood improvements and job retention and Acme’s continued investments in the community; and declaring an emergency.

**ORD. NO. 393-2008** authorizing a Conditional Use to construct a 12-unit apartment complex on the north side of Eastwood Avenue, east of Robin Ridge Boulevard and west of Colony Park Drive; and declaring an emergency.

**RES. NO. 394-2008** urging the Ohio Legislature to support House Bill 92 and work toward establishing guidelines or standards for remediation and cleanup of methamphetamine contamination; and declaring an emergency.

**ORD. NO. 395-2008** establishing a video service provider fee to be paid by any video service provider offering video service in the City, and supplementing Ordinance No. 596-2007; and declaring an emergency.

**ORD. NO. 396-2008** authorizing and directing the submission to the electors of the City of Akron of a proposal to amend the Charter of the City of Akron by placing the Clerk of Council position in the unclassified, to be voted upon at the election on November 4, 2008; and declaring an emergency.

**ORD. NO. 397-2008** authorizing and directing the submission to the electors of the City of Akron of a proposal to amend the Charter of the City of Akron by the addition of a new Section 98 "Akron Scholarship Plan" to be voted upon at the election on November 4, 2008; and declaring an emergency.

**ORD. NO. 398-2008** authorizing and directing the submission to the electors of the City of Akron of a proposal to amend the Charter of the City of Akron by the addition of a new Section 64 "Sale, Lease, or Transfer of City Utilities" to be voted upon the election on November 4, 2008; and declaring an emergency.
