

## **ORDINANCES AND RESOLUTIONS PASSED OCTOBER 27, 2008**

**ORD. NO. 471-2008** authorizing the Director of Public Service to grant a sewer easement on City watershed property to Rothenbuhler West, LLC; and declaring an emergency.

**ORD. NO. 472-2008** authorizing the Director of Health to enter into a contract with Keep Akron Beautiful, Inc. for the provision of private property trash and litter removal services; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 473-2008** authorizing the Director of Health to enter into a personal services contract with Cereatha Boyd for WIC Immunization Technical Services; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 474-2008** accepting conveyance(s) by deed of estates in fee simple of property in the City of Akron, for the EDGEWOOD REDEVELOPMENT AREA project; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 475-2008** authorizing the Director of Public Service to execute, on behalf of the City, an addendum to the oil and/or gas lease agreement for the mineral rights of City-owned land in Portage County to GonzOil, Inc., to include gas/oil well unitization in the northern half of the Lake Rockwell area; and declaring an emergency.

**ORD. NO. 476-2008** authorizing the Mayor, the Director of Public Service, the Director of Health, and /or the Director of Finance to enter into contracts, after publicly advertising for bids, for the purchase of materials and services needed by various City departments for a period of time not to exceed 3 years; approving the specifications therefore; and declaring an emergency.

**ORD. NO. 477-2008** amending and/or supplementing Title 19 of the Code of Ordinances to permit temporary signs on industrial, commercial or retail property in the vicinity of construction of public improvements; and declaring an emergency.

**ORD. NO. 478-2008** authorizing a Conditional Use to construct an addition to the grocery store / retail building at 1375 Copley Road; and declaring an emergency.

**ORD. NO. 479-2008** authorizing the Director of Public Service to file an application and enter into a grant agreement for funding from the Safe Routes to School Program through the Ohio Department of Transportation; and declaring an emergency.

**ORD. NO. 480-2008** ratifying the actions of the Director of Public Service in entering into a contract with various contractors for emergency snow and ice removal due to the storm on March 7 and 8, 2008; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 481-2008** authorizing the Director of public Service to enter into a contract with KMS & Associates, Ltd. for consulting service to inspect roadway pavement and arterial

and collector subsystems, update the computer system and provide training; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 482-2008** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of improvements to the fire sprinkler system at the Cascade Parking Garage; approving specifications therefore; and declaring an emergency.

**ORD. NO. 483-2008** authorizing the Mayor to file an application and enter into a grant agreement for Juvenile Accountability Block Grant funding through the State of Ohio; authorizing the expenditure of local matching funds; and declaring an emergency.
