

ORDINANCES AND RESOLUTIONS PASSED APRIL 6, 2009

ORD. NO. 153-2009 accepting a dedication plat for a section of Edgewood Boulevard, between Vernon Odom Boulevard and Westerly Road, for the extension of Westerly Road from east of Edgewood Boulevard westward to Raymond Street, for Rita Dove Lane, between Westerly Road and Warner Court, and for Mary Peavy Eagle Court, between Edgewood Boulevard and Rita Dove Lane, and a replat of Blocks D, E, & F of Edgewood Homes Phase 1, Lots 1 & 2 of Solomon Bare's Allotment on the north side of Vernon Odom Boulevard, south of Westerly Drive and east of Rhodes Avenue, and Lots 47, 48, 49, 50 & 52 of the F.J. Wettach Allotment on the east side of Raymond Street between Vernon Odom Boulevard and Euclid Avenue; and declaring an emergency.

ORD. NO. 154-2009 amending Section 190.102 of the Code of Ordinances of the City of Akron to change the qualifications of the Superintendent of Building Inspection; and declaring an emergency.

ORD. NO. 155-2009 authorizing a Conditional Use to construct an addition to a grocery store at 230 Howe Avenue; and declaring an emergency.

ORD. NO. 156-2009 authorizing a Conditional Use to permit the construction of the Windemere Elementary Community Learning Center at 2283 Windemere Avenue; and declaring an emergency.

ORD. NO. 157-2009 authorizing a Conditional Use to permit the construction of the Dr. Thomas McEbright Community Learning Center at 349 Cole Avenue; and declaring an emergency.

ORD. NO. 158-2009 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of a 16-inch water main on Albrecht Avenue and a 12-inch water main on Edith Avenue; approving specifications therefore; and declaring an emergency.

ORD. NO. 159-2009 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the renovation of the basketball courts and parking area at Davenport Park; approving specifications therefore; and declaring an emergency.

RES. NO. 160-2009 declaring it necessary to improve Manchester Road between the termini of West Waterloo Road and West Wilbeth Road by paving; grading; constructing and reconstructing curbs, concrete sidewalks, driveway approaches and storm sewers; installing roof drain pipes; providing street lighting; and planting trees; and declaring an emergency.

ORD. NO. 161-2009 authorizing the Mayor to apply for funds and enter into a grant agreement from the "2009 Project Safe Neighborhoods" grant administered through the State of Ohio, Office of Criminal Justice Services; and declaring an emergency.

RES. NO. 162-2009 congratulating the members of the St. Vincent-St. Mary Boys High School Basketball Team and their coaches on the occasion of winning the Division II State Championship; and declaring an emergency.

RES. NO. 163-2009 declaring that the City of Akron will spend federal economic stimulus funds to "Buy American" to the extent permitted by law in order to maximize the creation of American jobs and restore the economic vitality of our communities; and declaring an emergency.
