

ORDINANCES AND RESOLUTIONS PASSED OCTOBER 26, 2009

ORD. NO. 456-2009 authorizing the Director of Health to enter into personal service contracts with various organizations to provide local AIDS Health Education, Prevention and Support Services in accordance with an approved grant from the Ohio Department of Health; authorizing payment therefor; and declaring an emergency.

ORD. NO. 457-2009 authorizing the Director of Health to enter into a contract with Keep Akron Beautiful, Inc. for the provision of private property trash and litter removal services; authorizing payment therefor; and declaring an emergency.

ORD. NO. 458-2009 authorizing the Director of Health to enter into a personal services contract with Cereatha Boyd for WIC Immunization Technical Services; authorizing payment therefor; and declaring an emergency.

ORD. NO. 459-2009 approving the historic designation of 795 and 803 West Market Street as a historic landmark; and declaring an emergency.

ORD. NO. 460-2009 authorizing a Conditional Use to place a fence to within 3 feet 6 inches of East Wilbeth Road at 397-399 South Firestone Boulevard; and declaring an emergency.

ORD. NO. 461-2009 authorizing for the issuance and sale of bonds in the maximum principal amount of \$14,000,000, for the purpose of refunding certain maturities of certain general obligation bonds issued in 1998, 2001, 2002, 2003, 2005, 2006 and 2007; and declaring an emergency.

ORD. NO. 462-2009 authorizing the Purchasing Agent to enter into a contract or contracts for the purchase of Accounting Software and Congestion Management software on behalf of Akron Metropolitan Area Transportation Study (AMATS); and declaring an emergency.

ORD. NO. 463-2009 authorizing the Director of the Department of Planning and Urban Development to enter into an agreement of cooperation with the County of Summit for the purchase of aerial photos; authorizing payment therefor; and declaring an emergency.

ORD. NO. 464-2009 authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the construction of the Little Cuyahoga River Restoration Phase I; approving specifications therefor; and declaring an emergency.

ORD. NO. 465-2009 authorizing the Director of Public Service to enter into a contract or contracts, after publicly advertising for bids, in connection with the Stubbs Stair Rehabilitation Project at the H.K. Stubbs Justice Center; approving specifications therefor; and declaring an emergency.
