

## **ORDINANCES AND RESOLUTIONS PASSED JANUARY 25, 2010**

**ORD. NO. 11-2010** authorizing the Purchasing Agent to enter into a contract, after publicly advertising for bids, for the sale of surplus ZFP printers; approving specifications therefore; and declaring an emergency.

**ORD. NO. 12-2010** accepting conveyance (s) by deed of estate in fee simple of property in the City of Akron, for the BRIDGESTONE/FIRESTONE project; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 13-2010** amending and/or supplementing Title 9, "Health, Safety and Sanitation", Chapter 94, Sections 94.15 "Storage of junk motor vehicles", 94.16 "Storage of unlicensed vehicles", 94.19 "Offensive or nauseous conditions", 94.20 "Graffiti", 94.29 "Noxious weeds", 94.30 "Inspection of premises for nuisances", 94.31 "Ordering improper conditions to be remedied-Notice and appeal", and 94.34 "Compost piles" of the Code of Ordinances of the City of Akron to combine services and enforcement under the Department of Public Service; and declaring an emergency.

**ORD. NO. 14-2010** amending and/or supplementing Title 15 "Land Usage", Chapters 150.01 "Definitions", 150.11 "Application of Other Codes", 150.03 "Notice of Violation", 150.031 "Notice of Violation Requiring Demolition", 150.05 "Hearings", 150.06 "Director of Health", 150.15 "Unfit Dwellings or Premises", 150.18 "Condemnation Placard", 150.25 "Warranties and Liability", 150.30 "Registration Required", 150.40 "Rental Unit Mandatory Inspection Required", and 150.99 "Penalty" of the Code of Ordinances of the City of Akron to combine services and enforcement under the Department of Public Service; and declaring an emergency.

**ORD. NO. 15-2010** amending and/or supplementing Section 95.02 and 95.17 of the Code of Ordinances of the City of Akron to combine services and enforcement under the Department of Public Service; and declaring an emergency.

**ORD. NO. 16-2010** amending and/or supplementing Section 111.561 and 111.564 of the Code of Ordinances of the City of Akron to combine services and enforcement under the Department of Public Service; and declaring an emergency.

**ORD. NO. 17-2010** designating the City as a recovery zone under Section I400U-1 of the Internal Revenue Code for the purpose of issuing recovery zone economic development bonds or recovery zone facility bonds; and declaring an emergency.

**ORD. NO. 18-2010** providing for the issuance and sale of notes in the maximum principal amount of \$14,000,000, in anticipation of the issuance of bonds, for the purpose of providing funds to pay expenses associated with the settlement of health care claims, whether by reserve or otherwise, and the City's portion of the costs of maintaining its self-insurance program for employee benefits; and declaring an emergency

**ORD. NO. 19-2010** determining to proceed with the improvement of South Main Street between certain termini by paving; constructing and reconstructing curbs, concrete sidewalks, and driveway approaches, constructing and reconstructing storm sewers, installing roof drain pipes; installing pedestrian lighting, and planting trees and installing tree grates, approving the report of the Assessment Equalization Board; and declaring an emergency.

**ORD. NO. 20-2010** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the purchase of a front end loader and snow removal blade; approving specifications therefore; and declaring an emergency.

**ORD. NO. 21-2010** authorizing the Director of Public Service to request proposals and enter into a contract with a consulting firm to update the airport's master plan; and declaring an emergency.

**ORD. NO. 22-2010** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for Phase 2 of the rehabilitation of the main taxiway at Akron Fulton Airport by reconstructing failed pavement areas, repairing major cracks, and performing incidental work; approving specifications therefore; and declaring an emergency.

**ORD. NO. 23-2010** authorizing the Purchasing Agent to enter into a contract with Premier Safety & Services, Inc. for the purchase of 5 Self-Contained Breathing Apparatus (SCBA's) for use by the Akron Police Department; authorizing payment therefore; and declaring an emergency.
