

## **ORDINANCES AND RESOLUTIONS PASSED FEBRUARY 8, 2010**

**ORD. NO. 32-2010** ratifying the actions of the Director of Public Service to enter into a contract with Kenmore Construction Co. for the emergency repair of the Canal Interceptor; authorizing payment thereof; and declaring an emergency.

**RES. NO. 33-2010** adopting the 2010 Capital Investment and Community Development Program, also known as the Capital Investment Budget; and declaring an emergency.

**RES. NO. 34-2010** declaring the necessity and intent of the City of Akron to appropriate a fee simple interest in real property owned by Albert and Charlene Brock located at 675 Mallison Avenue, for the purposes of eliminating conditions of blight and preventing the recurrence of blight and furthering objectives of the Edgewood Urban Renewal Plan; and declaring an emergency.

**ORD. NO. 35-2010** directing the appropriation of a fee simple interest in real property owned by Kevin K. Preston, located at 663-665 Mallison Avenue, for the purposes of eliminating conditions of blight and preventing the recurrence of blight and furthering the objectives of the Edgewood Urban Renewal Plan; and declaring an emergency.

**ORD. NO. 36-2010** directing the appropriation of a fee simple interest in real property owned by IWB, LLC, located at 667 Mallison Avenue, for the purposes of eliminating conditions of blight and preventing the recurrence of blight and furthering the objectives of the Edgewood Urban Renewal Plan; and declaring an emergency.

**ORD. NO. 37-2010** authorizing the Mayor to enter into a loan guaranty agreement with the International Soap Box Derby, Inc., and FirstMerit Bank; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 38-2010** authorizing the Director of Planning and Urban Development to enter into an agreement with the Urban Neighborhood Development Corporation (UNDC) to provide for the construction and sale of moderate cost single-family homes on a non-profit basis within the Community Development Activity Area; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 39-2010** authorizing the Mayor to file a grant application and enter into an agreement with the Ohio Department of Natural Resources to receive funding for certain capital improvements through the State of Ohio's Clean Ohio Trail Fund to construct the Northside Train Station Connector; and declaring an emergency.

**ORD. NO. 40-2010** authorizing the Director of Public Service to submit an application and enter into an agreement with the Summit/Akron Solid Waste Management Authority for a Community Recycling Access Grant; and declaring an emergency.

**ORD. NO. 41-2010** authorizing the Director of Public Service to enter into a contract with the Akron Amateur Basketball Officials Association for the provision of officials for the city-wide youth basketball program during the 2010 season; authorizing payment therefore; and declaring an emergency.
