

## ORDINANCES AND RESOLUTIONS PASSED JULY 26, 2010

**ORD. NO. 255-2010** authorizing the execution of a contract for sale for private redevelopment with Involta LLC; providing for the sale and redevelopment of property in the Sweitzer Redevelopment Area; finding such Property is not needed for any public use, and related findings; and declaring an emergency.

**ORD. NO. 256-2010** accepting a sewer easement for property described below in the City of Akron, for the MASSILLON ROAD SEWER project; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 257-2010** accepting a utility easement for property described below in the City of Akron, for the MASSILLON ROAD SEWER project; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 258-2010** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for furnishing and applying airport pavement markings to runway and taxiway pavement at the Akron Fulton Airport; approving specifications therefore; and declaring an emergency.

**ORD. NO. 259-2010** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for the disposal of miscellaneous “white goods”; approving specifications therefore; and declaring an emergency.

**ORD. NO. 260-2010** authorizing the Director of Public Service to enter into an agreement with the Ohio Director of Transportation for the resurfacing of Wilbeth Road and Exchange Street; and declaring an emergency.

**ORD. NO. 261-2010** ratifying the actions of the Director of Public Service in contracting with H.M. Miller Construction Company for emergency construction of the Ascot Parkway Storm Sewer; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 262-2010** ratifying the actions of the Director of Public Service in contracting with H.M. Miller Construction Company for emergency repairs to the Little Cuyahoga Interceptor sewer and the Freemont sanitary sewer; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 263-2010** authorizing the Director of Public Service to enter into a contract, after publicly advertising for bids, for repairs to the State Street Parking Deck; approving specifications therefore; and declaring an emergency.

**ORD. NO. 264-2010** authorizing the Mayor to file an application and enter into an agreement with the Ohio Water Development Authority for an OWDA loan to provide funding for certain sewer Consent Decree/ Sewer System Improvement Projects; and declaring an emergency.

**ORD. NO. 265-2010** authorizing the Interim Director of Health to enter into an agreement with Ritzman Pharmacies, Inc. for the provision of prescription drug dispensing services to the patients of the Akron Health Department; authorizing payment therefore; and declaring an emergency.

**ORD. NO. 266-2010** authorizing the Interim Director of Health to enter into a contract with the Summit County Health Department for funding from the Ohio Department of Health 2011 Public Health Emergency Preparedness fund for infectious diseases response, bio-terrorism preparedness and other public health emergencies and to develop and execute contracts as necessary to fulfill the obligations of the grant; and declaring an emergency.

**ORD. NO. 267-2010** amending and/or supplementing Title 3 “Administration”, Chapter 30 “Mayor and Council” to clarify § 30.10 “Definitions”, and declaring an emergency.

**ORD. NO. 268-2010** determining to proceed with the improvement of Tallmadge Avenue between certain termini by paving, constructing and reconstructing curbs, concrete sidewalks, driveway approaches, storm sewers, sanitary sewers, and water mains, installing roof drain pipes and street lighting, constructing retaining walls, and planting trees and installing tree grates, all together with the necessary appurtenances, approving the report of the Assessment Equalization Board, and declaring an emergency.

**ORD. NO. 269-2010** authorizing the Mayor and Director of Public Service to apply for an enter into agreements for grants and loans from the United States Department of Energy for improvements to the City's steam, hot water and chilled water system; approving an agreement between the City of Akron and Akron Energy Systems LLC relating to the financing of certain improvements to the City's steam, hot water and chilled water system and the sale of certificates payable from payment made under such agreement, and authorizing the execution of that agreement; and declaring an emergency.

**ORD. NO. 270-2010** authorizing the Mayor to enter into an agreement with Albrecht, Incorporated for the acquisition of property located in Highland Square on West Market Street; and declaring an emergency.

**ORD. NO. 271-2010** authorizing the Director of Planning and Urban Development to file an application with the United States Department of Housing and Urban Development for the Community Challenge Planning Grant; to enter into all necessary contracts for the operation and term of the Program; and declaring an emergency.

**ORD. NO. 272-2010** approving the sale of City owned property to Lundy Robinson, Jr. and Brenda J. Robinson; determining that said property is not needed for public use; accepting conveyance by deed of estate in fee simple of property in the City of Akron in connection with the Hickory Corridor Urban Renewal Area project and Disposition Policy for Community Development Areas; and declaring an emergency.

**ORD. NO. 273-2010** authorizing the Mayor to apply for and enter into an agreement with the State of Ohio Office of Criminal Justice Service for the 2010 Ohio Prescription Drug Grant to target investigations dealing with illegal prescriptions; and declaring an emergency.

**RES. NO. 274-2010** expressing appreciation to LeBron James for his extraordinary basketball accomplishments and his continuing involvement in the Akron community; and declaring an emergency.

**RES. NO. 275-2010** expressing support for the consolidation of health services of the Summit County Health District and the City of Akron; and declaring an emergency.

NO. 277-2010** providing for the issuance and sale of notes in a principal amount not to exceed \$10,000,000 to pay the property owners' portion, in anticipation of the levy and collection of special assessments, of the cost of improving certain streets in the city, between certain termini, by providing street cleaning services and street lighting; and declaring an emergency.
