

ORDINANCES AND RESOLUTIONS PASSED JUNE 17, 2013

ORD. NO. 180-2013 authorizing the Mayor to file an application and enter into an agreement with the Ohio Environmental Protection Agency for loans from the Water Supply Revolving Loan Fund to fund capital projects for the Water Supply Bureau; and declaring an emergency.

RES. NO. 181-2013 approving and confirming the reappointment of Stephen A. Stock to the Akron Civil Service Commission; approving and confirming the appointments of Candace Campbell Jackson and John Otterman to the Akron Civil Service Commission; and declaring an emergency.

ORD. NO. 182-2013 authorizing a Conditional Use to permit the construction of storage units at 1300-1304 Brittain Road; and declaring an emergency.

ORD. NO. 183-2013 authorizing a Conditional Use to permit the construction of an addition to a residential group home at 564 Diagonal Road; and declaring an emergency.

ORD. NO. 184-2013 authorizing the execution of a development agreement with LEBO Holdings LLC for a commercial development in the Highland Square renewal area; and declaring an emergency.

ORD. NO. 185-2013 declaring improvements to certain parcels of real property to be a public purpose, describing the public improvements to be made to directly benefit those parcels, requiring the owner of the improvements thereon to make service payments in lieu of taxes, for deposit into a municipal public improvement tax increment equivalent fund, and related authorizations pursuant to Ohio Revised Code Sections 5709.40, 5709.42 and 5709.43; and declaring an emergency.

ORD. NO. 186-2013 authorizing a Conditional Use to construct a retail/apartment development at 795 West Market Street.

ORD. NO. 187-2013 authorizing the issuance and sale of bonds in the maximum principal amount of \$8,000,000, for the purpose of refunding certain maturities of general obligation bonds of the City issued in 2010; and declaring an emergency.

ORD. NO. 188-2013 authorizing the issuance and sale of bonds in the maximum principal amount of \$27,000,000, for the purpose of refunding certain maturities of general obligation bonds of the City issued in 2010; and declaring an emergency.

ORD. NO. 189-2013 authorizing the issuance and sale of bonds in the maximum principal amount of \$40,000,000, for the purpose of refunding certain maturities of general obligation bonds of the City issued in 2005; and declaring an emergency.

ORD. NO. 190-2013 authorizing the Mayor to file applications and to enter into agreements for funding of certain capital improvements under the Ohio Public Works Commission's Local Transportation Improvement Program (LTIP) and the State Capital Improvements Program (SCIP); committing City funds for the local share of these improvements; and declaring an emergency.

RES. NO. 191-2013 opposing and objecting to the application of Dolgen Midwest, LLC, DBA Dollar General Store 11853, 1045 Vernon Odom Boulevard, Akron, Ohio 44307 for a Class C1, C2 liquor permit (22348151690) now pending before the Division of Liquor Control; and declaring an emergency.
