ORDINANCES AND RESOLUTIONS PASSED DECEMBER 12, 2016:

ORD. NO. 392-2016 declaring certain improvements to real property, located at West Market Street and North Hawkins Avenue in the City of Akron, to be a public purpose and exempt from real property taxation, describing the public improvements to be made that directly benefit those parcels, requiring the owner of the improvements thereon to make service payments in lieu of taxes, providing for the collection of service payments in lieu of taxes and the deposit of those service payments in the appropriate fund; providing for the payment of a portion of the service payments to the Akron Public School District, all pursuant to Ohio Revised Code Sections 5709.40 to 5709.43 (the "Act"); and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 393-2016 approving the sale of an interest in real property of City-owned land in the form of a right of first refusal and authorizing the Mayor or his designee to enter into an agreement regarding the same; determining said property interest is not needed for public use; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 394-2016 approving and authorizing the execution of a Contract for Lease and Sale of Land for Private Redevelopment, providing for the lease and/or sale and redevelopment of property on Ascot Parkway to Pickard Commercial Group, LTD, or its designee, pursuant to the Ascot Urban Redevelopment Plan; finding such property is not needed for any public use, and related findings; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 395-2016 authorizing the Director of Public Service to enter into a contract or contracts after publicly advertising for bids for the construction of the Maryland Avenue Street Improvements; approving the specifications thereof; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 396-2016 amending and/or supplementing Title 9 "General Provisions," Chapter 94 "Health, Safety and Sanitation," Section 29 of the Code of Ordinances of the City of Akron, establishing more efficient procedures to mow high weeds and grass on neglected lots; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 397-2016 authorizing the Mayor to enter into an automatic aid agreement with the Village of Mogadore regarding matters involving fire services and emergency medical services; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 398-2016 authorizing the Mayor to apply for and accept if awarded a grant from the Department of Homeland Security, Federal Emergency Management Agency's "Assistance to Firefighters Grant Program" for equipment; authorizing the Mayor through the Purchasing Agent to enter into an agreement or agreements to carry out the terms of the grant by purchasing the equipment necessary to carry out the purpose of the grant; authorizing the expenditure of local funds; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 399-2016 authorizing the Mayor to apply for and accept if awarded a grant from the Department of Homeland Security, Federal Emergency Management Agency's "Assistance to Firefighters Grant Program" for a vehicle; authorizing the Mayor through the Purchasing Agent to enter into an agreement or agreements to carry out the terms of the grant by purchasing the equipment necessary to carry out the purpose of the grant; authorizing the expenditure of local funds; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 400-2016 authorizing the Mayor to accept grant funding from the Akron Community Foundation, Health and Human Services Community Fund grant for the continuation of the "Hidden in Plain Sight" program; authorizing the expenditure of the grant funds; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 401-2016 authorizing the Mayor to accept grant funding from the Akron Community Foundation, Howard Atwood Family Fund for the continuation of the "Hidden in Plain Sight" program; authorizing the expenditure of the grant funds; and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 402-2016 amending Ordinance No. 82-2016, passed March 28, 2016, and Ordinance No. 294-2016, passed September 26, 2016, which established the annual appropriation for the current expenses, other expenditures and the capital outlays of the City of Akron for the fiscal year ending December 31, 2016, and declaring an emergency. ***VOTE: 12-0***

ORD. NO. 403-2016 authorizing a Conditional Use to place signage at 855 West Market Street; and declaring an emergency. ***VOTE: 12-0***
