## **ORDINANCES AND RESOLUTIONS PASSED APRIL 3, 2017:**

**ORD. NO. 85-2017** authorizing the Mayor to apply for and to enter into an agreement with the State of Ohio, Department of Education, for After School Program grants for the 2017-2018 school year; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 86-2017** approving the donation of various City-owned properties to the Summit County Land Bank; determining said property is not needed for public use; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 87-2017** approving the sale of various City-owned properties; determining said property is not needed for public use; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 88-2017** authorizing the Director of Planning and Urban Development, after publicly advertising for bids, to enter into an agreement for title, appraisal and review appraisal services to carry out the Community Development Program and other programs; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 89-2017** authorizing the Director of Public Service to file applications and enter into grant agreements for funding from the Safe Routes to School Program through the Ohio Department of Transportation, in order to implement infrastructure improvements and provide programming that will encourage and enable students to walk or bike to school; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 90-2017** authorizing the Mayor to enter into Sponsorship Agreements with the Village of Williamsburg for the Williamsburg Low Head Dam Removal project and with the Appalachia Ohio Alliance for the Cackley Swamp/Kiser Property Acquisition and Restoration project and for the Scioto River Preserve Phase 2 project; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 91-2017** amending Ordinance 38-2017 to authorize the Director of Public Service through the Purchasing Agent, without the formality of publicly advertising for bids, to enter into a contract or contracts for the purchase of replacement primary tank parts for the Water Reclamation Facility from Bissnuss, Inc.; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 92-2017** amending Ordinance 39-2017 to authorize the Director of Public Service through the Purchasing Agent, without the formality of publicly advertising for bids, to enter into a contract or contracts for the purchase of spare primary tank parts for the Water Reclamation Facility; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 93-2017** authorizing a Conditional Use to establish a living community for artists with exhibition and performance space on the west side of North Howard Street, north of Beech Street to be known as the Akron Soul Train; and declaring an emergency. **VOTE: 13-0**

**ORD. NO. 94-2017** authorizing a Conditional Use to increase the height of a high-rise sign at 670 E. Cuyahoga Falls Avenue; and declaring an emergency. ***VOTE: 13-0***

**RES. NO. 95-2017** approving and confirming the reappointment by the Mayor of Renee Greene as a member of the City Planning Commission; and declaring an emergency. ***VOTE: 13-0***

**RES. NO. 96-2017** approving and confirming the appointment by the Mayor of Tina Boyes as a member of the City Planning Commission; and declaring an emergency. ***VOTE: 13-0***

**ORD. NO. 97-2017** authorizing the Purchasing Agent to enter into a contract, after publicly advertising for bids, for the purchase of water meters and meter accessories in order to provide accurate and efficient billing services to the City's utility customers; and declaring an emergency. ***VOTE: 13-0***
