ORDINANCES AND RESOLUTIONS PASSED JUNE 12, 2017:

ORD 186-2017 declaring the necessity of, determining to proceed with, and levying special assessments for the improvement of certain streets in the City by constructing, reconstructing and repairing concrete sidewalks, driveway approaches, curbs and retaining walls and installing roof drain pipes; all in accordance with petitions submitted by property owners under the 2016 City-Wide Sidewalk Program; and declaring an emergency. **VOTE 13-0**

ORD 187-2017 authorizing the Director of Public Service, after publicly advertising for bids through the Office of the Purchasing Agent, to enter into a contract or contracts for the construction of improvements for the Safe Routes to School 2015 program; and declaring an emergency. **VOTE 13-0**

ORD 188-2017 authorizing the Director of Public Service to enter into an emergency contract with Cardinal Environmental for the reconstruction of the Civic Theater building wall adjacent to where the former Stage Left building stood; and declaring an emergency. **VOTE 13-0**

ORD 189-2017 authorizing the Purchasing Agent, without the formality of publicly advertising for bids, to enter into a contract or contracts for the purchase of a replacement gate actuator for the Water Reclamation Facility; and declaring an emergency. **VOTE 13-0**

ORD 190-2017 authorizing the Director of Finance to reimburse the County of Summit for the costs of construction to relocate a water main in Arlington Road in the vicinity of Warner Road as part of an overall roadway improvement project; and declaring an emergency. **VOTE 13-0**

ORD 191-2017 authorizing the Director of the Department of Neighborhood Assistance to enter into a contract with the Catholic Charities Community Services Corporation for the operation of the summer recreation program for youth with disabilities, in order to support this successful and valuable program for the benefit of the disabled youth in our community; and declaring an emergency. **VOTE 13-0**

ORD 192-2017 approving the donation of City-owned land located at V.L. Westwood Ave. to West Hill Neighborhood Organization, determining said property is not needed for public use; and declaring an emergency. **VOTE 13-0**

ORD 193-2017 authorizing the Director of Planning and Urban Development to file an application and enter into an agreement with the State of Ohio for the Homeless Crisis Response Program; and declaring an emergency. **VOTE 11-0 (Omobien and Freeman abstained)**

ORD 194-2017 authorizing the Director of Neighborhood Assistance through the Purchasing Agent, to enter into a contract or contracts, after obtaining quotes, in an amount not to exceed \$15,000.00, for the purchase and installation of baby changing facilities in certain Akron parks and community centers; and declaring an emergency. **VOTE 13-0**
