## ORDINANCES AND RESOLUTIONS PASSED SEPTEMBER 18, 2017:

ORD 279-2017 levying special assessments for the improvement of East Market Street in the City by paving, grading, constructing, reconstructing and installing curbs, concrete sidewalks and driveway approaches, all together with the necessary appurtenances thereto; all in accordance with the Petition submitted by the property owner of the benefitted property; and declaring an emergency. **VOTE 13-0**

ORD 280-2017 levying special assessments and determining to proceed with the improvement of various off-street parking facilities in the Kenmore Business District and the Canton Road Business District by sealing, resurfacing and repairing, painting parking space stripes, sweeping, removing snow, cleaning sewer openings, providing lawn, turf, shrub and tree maintenance, litter and other general clean-up and otherwise improving and maintaining the same, and all when and where necessary; and declaring an emergency. **VOTE 13-0**

ORD 281-2017 authorizing the Purchasing Agent, after publicly advertising for bids, to enter into a contract for the repair and/or replacement of the concrete apron located at or around the Fire Maintenance Building, 2474 Triplett Blvd.; and declaring an emergency. **VOTE 13-0**

ORD 282-2017 authorizing the Director of Public Service, through the office of the Purchasing Agent, after publicly advertising for bids, to enter into a contract for the installation of a non-potable water meter vault at the Akron Water Reclamation Facility; and declaring an emergency. **VOTE 13-0**

ORD 283-2017 authorizing the Purchasing Agent, after publicly advertising for bids, to enter into a contract for the purchase of various equipment, materials and labor in order to complete certain concrete work at the Akron Water Plant located at 1570 Ravenna Road in Kent, Ohio; and declaring an emergency. **VOTE 13-0**

ORD 284-2017 authorizing the Director of Public Service, through the office of the Purchasing Agent, after publicly advertising for bids, to enter into a contract for the replacement of two (2) electric distribution switches at the Akron Water Reclamation Facility; and declaring an emergency. **VOTE 13-0**

ORD 285-2017 authorizing the Mayor or his designee to apply for and accept, if awarded, a grant administered through the United States Department of Justice, Bureau of Justice Assistance designed to provide law enforcement agencies with the flexibility to prioritize and utilize justice funds where they are needed most; and declaring an emergency. **VOTE 13-0**

ORD 286-2017 authorizing a Conditional Use to establish a medical marijuana cultivation facility at 3081 Gilchrist Road; and declaring an emergency. (9/11/17) **VOTE 13-0**

ORD 287-2017 authorizing the Mayor to accept the Fire Prevention and Safety Grant from the Department of Homeland Security; authorizing the expenditure of matching funds; and declaring an emergency. **VOTE 13-0**

RES 288-2017 opposing and objecting to the application of Hibachi Express Ohio, LLC, 456 E. Exchange Street, Akron Ohio 44304 for a Class D5 and D6 liquor permit (9598200) now pending before the Division of Liquor Control; and declaring an emergency. This application is a request for transfer of ownership of a permit at the above listed location. **VOTE 13-0**
