PLANNING

1. ORDINANCE approving the 2018 Consolidated Action Plan including applications and certifications for the Community Development Block Grant (“Community Development”), the HOME Investment Partnership (“HOME”) and Emergency Solutions Grant (“ESG”) Programs; authorizing the Director of Planning and Urban Development to enter into all necessary contracts for the operation and term of the Programs; and declaring an emergency. *(Scheduled for Public Hearing July 9, 2018)*
2. ORDINANCE authorizing a Conditional Use to construct a single-family detached allotment on the northwest side of Diagonal Road, south of Copley Road; and declaring an emergency. *(Scheduled for Public Hearing July 9, 2018)*
3. ORDINANCE authorizing a Conditional Use to establish a child day care business center at 348 Pioneer Street; and declaring an emergency. *(Scheduled for Public Hearing July 9, 2018)*
4. ORDINANCE amending/supplementing Title 15, Chapter 153, “Zoning Code”, Section 153.296 “Biomedical Use District – Class UB” by expanding permitted uses allowed; and declaring an emergency. *(Scheduled for Public Hearing July 16, 2018)*

9. ORDINANCE determining to proceed with the improvement of Forest Edge Drive, Aeries Way, Carriage Hill Lane, Fox Trace Trail, High Hampton Trail, Timberline Trail, Bent Creek Trail and Deer Ridge Run between certain termini by paving; grading and resurfacing; and declaring an emergency.
10. ORDINANCE authorizing the Director of Public Service, or his designee, to pay the insurance deductible to Kenworth of Canton for repairing the damage to an automated side-loading refuse-collection truck; and declaring an emergency.
11. ORDINANCE authorizing the Mayor to file applications and enter into agreements with the Ohio EPA and Ohio Water Development Authority for a Water Pollution Control Loan to fund the construction of the Uhler Conveyance (CSO Rack 27 and 29) Project; and declaring an emergency.
