ORDINANCES & RESOLUTIONS PASSED NOVEMBER 19, 2018

- 1 RES 390-2018 recognizing and celebrating the 50th anniversary of The Reporter Newspaper, and declaring an emergency. VOTE 11-0 (Sommerville, Freeman absent)
- 2 ORD 391-2018 authorizing the Mayor or his designee, without the formality of publicly advertising for bids, to enter into a contract with Official Payments Corporation for on-line credit card payment acceptance, on-line e-check acceptance, and interactive-voice response payment abilities; and declaring an emergency. VOTE 11-0 (Sommerville, Freeman absent)
- 3 RES 392-2018 approving and confirming the appointment of Marco Sommerville to the Summit County Combined General Health District Board of Health for the four-year term commencing January 1, 2019 and ending December 31, 2022; and declaring an emergency. VOTE 11-0 (Sommerville, Freeman absent)
- 4 ORD 393-2018 authorizing the Mayor to execute and deliver a Development Agreement between the City and Huntington National Bank; and declaring an emergency. VOTE 11-0 (Sommerville, Freeman absent)
- 5 ORD 394-2018 authorizing a Conditional Use to construct a parking lot addition at 722-726 Sherman Street; and declaring an emergency. VOTE 11-0 (Sommerville, Freeman absent)
- 6 ORD 395-2018 authorizing a Conditional Use to construct a gasoline fueling station and convenience store at the southeast corner of Brittain Road and Eastwood Avenue; and declaring an emergency. VOTE 11-0 (Sommerville, Freeman absent)
- 7 ORD 396-2018 authorizing the Mayor, or his designee, to enter into a lease agreement with Stark State College to lease City-owned land at the Akron Fulton Airport for use as a commercial driver's license driving school; and declaring an emergency. VOTE 11-0 (Sommerville, Freeman absent)
